Funding Regional Transportation

Roles in the Regional Funding Process



- Federal Transportation Bill—Fixing America's Surface Transportation (FAST) Act signed in December 2015
- Sets funding levels and allocates money to States



- Pass federal funds to MPOs
- Responsible for administering funds to MPOs, counties, and municipalities



- Complete federal requirements; Long Range Transportation Plan and Transportation Improvement Program
- Receive federal funds for projects and planning
- Create a regionally cooperative process for distribution of federal funds to local government members

Local Sources of Funding

Local governments provide a significant portion of funds for regional transportation projects. Local matches and local overmatches can come from a variety of sources, such as sales taxes or general obligation bonds.

Federal Sources of Funding

Federal grants also provide a portion of regional transportation funding. Federal funding generally falls under one of the following categories:

- Surface Transportation Block Grant (STBG): Funds for improving highways, bridges, transit, or bike and pedestrian infrastructure
- Congestion Mitigation and Air Quality (CMAQ): Funds for projects that help meet Clean Air Act Standards
- Transportation Alternatives (TA): Funds for alternative transportation options like recreational trails and small environmental mitigation projects

Public Involvement in Regional Transportation and Air Quality Planning

Metropolitan Planning Organizations (MPOs)

- Federally designated regional planning agencies formed for urbanized areas with a population of 50,000 or more
- Facilitate regional transportation decisions regarding infrastructure, programing, safety, and air quality
- Funded through local and federal government sources, including Federal Highway
 Administration (FHWA) and Federal Transit
 Administration (FTA) funds; though sometimes state funding is available

Why MPOs are Important

- Maintain continuous, comprehensive, and collaborative planning at a regional scale
- Transportation and environmental systems often span regions that extend beyond individual communities
- Develop plans that address air quality, congestion, and transportation infrastructure improvements at a regional scale
- Provide an efficient means of allocating federal funding to projects that enhance regional transportation and air quality

Public Participation Process and Opportunities

Public involvement is a vital part of the regional planning process and includes everything from outreach and education, to serving on councils and committees.
