Discussion

- Economic Benefits of Trails Proposal
 - Boring opened the discussion and stated his interest in developing a document to describe economic impacts of bicycle infrastructure
 - Document should include research to show trails raise adjacent property values and create jobs
 - Jacobsen stated there may be funding available for economic research through CDOT's
 Research Group through an application process. Applications are typically due in November
 - Boring stated the importance of involving multiple stakeholders, such as municipalities, universities, and development companies that may be interested in planning and constructing bicycle and pedestrian networks
 - Schneiders mentioned it may be of interest to think about having a Masters or Doctoral candidate at a local university develop the research as part of a thesis / dissertation
 - Willis asked what agency would sponsor and oversee the project
 - The group discussed the possibilities of several organizations: private firms, public agencies, or a university planning program
 - The Collaborative will organize elements of the study and possibly develop an RFP for a private firm, public agency, or university (student thesis)
 - Selders mentioned the benefits of looking at recent local and regional bicycle plans (i.e. Greeley and Fort Collins) for economic impact information contained in those plans
 - Boring will organize a steering committee of interested individuals from the collaborative to develop a research proposal

I-25 Trail Crossing

 Boring and Friesen presented a map depicting existing and planned Poudre Trail segments as the trail approaches I-25. The current plan for crossing I-25 along the trail is for a temporary crossing using the existing Harmony interchange. Boring stated previous funding from GOCO was being repurposed to extend the trail to the Harmony Transfer Center.

- The group discussed plans for the Poudre River Bridge replacement and a possible trail underpass with the new bridge
 - Schneiders clarified that the bridge is not slated for replacement in the near future (did not sustain catastrophic damage during 2013 floods and is not required to be replaced)
- The group discussed constructing an underpass along the Great Western Railroad corridor utilizing the existing bridge structure and grade separation
 - There is not enough room immediately adjacent to the RR tracks under the existing bridge
 - The group discussed the possibility of punching a new underpass under the existing bridge grade
 - Schneiders mentioned that the group should remain in close discussion with CDOT on any plans to bore/punch a new underpass under existing grade as it technically breaks the plane of I-25
- Boring mentioned having a discussion with key players in the Poudre River Trail crossing including NoCo Bike and Ped, affected municipalities, and CDOT
- Next Steps: Schneiders agreed to discuss possibilities with CDOT representatives and continue a discussion with affected parties
