STC Chair Updates

MEETING NOTES	Meeting notes approved as written.
UPDATES	Senior Travel Training Program – Travel Training went well, signing more people up. First two sessions sold out and two more events scheduled. Larimer County Senior Transportation – Discussion occurred during Mallette's presentation.

Discussion Items

DRIVESMART COMMUNITY DISCUSSION	Gordon discussed the Drive Smart event held at Silverleaf Apartments in Loveland on January 25 th . Major discussion items at the event included driving challenges, limitations, and requirements. Challenges mentioned included: speed, congestion leading to distracted driving, vision and hard-to-see lane markings and signs, roundabouts and the need for education to use them, parking lot designs, and better lighting. Multiple drivers stated they do not drive unless necessary and never at night. Most drivers stated they would like a refresher course for driving.
TRANSIT PLANNING FUNDS	Gordon discussed the Transit Planning 4 All funding opportunity. Applications are due March 18 th .
LARIMER COUNTY SENIOR TRANS STUDY	Larimer County's 2013 Strategic Plan was included in the meeting packet; specifically Goal 4.2 pertains to senior transportation needs in the unincorporated areas of the County. Mallette is in the process of hiring a consultant to research what is happening in the region, including what services already exists, and where the need is for additional service and where there are gaps. Mallette stated she would like to use the STC as a steering committee to review research done by the consultant, develop and review a survey, and brainstorm next steps. Process should be completed by the end of the year. STC members stated preliminary work can be done while Mallette writes RFP. Do we need a consultant for research? Take advantage of people in this group who have knowledge. Mallette will send questions to
