- 4. Chair Updates.....Thomas
  - Senate Bill 11 would take transit out of FASTER transportation bill. Currently provides \$400,000 to Fort Collins
  - Transfort reported ridership of 3.2 Million in 2015, up from 2.2 Million. MAX is at almost 1 Million riders
  - Senior Transportation Coalition discussed growing older in Fort Collins. Berthoud and Loveland did a travel training and the first session was a success. March and April are opened as well
  - Gary is a member of the Governor's Blue Ribbon Panel concerning growing older in Colorado. There is a transportation and housing committee, which discussed the need for connections between the two and the need for more density

#### 5. Discussion Items

- 2016 LCMC Goals (Gordon) Alex discussed the goals for the LCMC in 2016.
   Members stated they would like to create a more informational group, require an RSVP, and move the meeting location around to attract more attendees. The April meeting could be held at Foothills Gateway and Cari offered the ARC conference room for later meetings. Goals should also focus on connecting Greeley and Loveland, connecting smaller towns to cities, and providing Sunday and more night service
- Larimer County Senior Transportation (Thomas) The STC is also discussing its purpose because it is similar to the LCMC
- Final 2016 NFRMPO Rider's Guide (Gordon) Alex handed out copies of the final draft of the 2016 NFRMPO Rider's Guides. Connects received included taking off the names of places that do not have service, adding Uber and Lyft, and distributing the Rider's Guides to local agencies, libraries, senior centers, transit
