6. Fix N I-25/Legislative update – David May/Sandra Solin – 30 minutes

Last year able to get \$ from GF

General agreement on TransBond as a financing mechanism

Broad recognition that SB228 is not an effective funding mechanism

November elections are a wild card

Sandra identified some critical paths for transportation discussion regardless of legislative make up (D&Rs).

Longer term discussion on gas tax vs sales tax - but complications due to public support on the margin. Short term - financing mechanism then a permanent commitment from Legislature for funding.

I-25 not done even though received the TIGER grant. Committed to statewide solution

Not done, need to retain credibility with rest of state Must be a short term and long term funding. Short term large cash infusion and long term stable dedicated funding source

Focused on 2017 for TransBond. Question is when does the funding source go on the ballot - 2018 not a good year.

Will know more after elections. Need to pull the trigger on the long term funding. ID timelines, objectives at retreat two weeks ago. Had a follow up. Need to produce a detailed work plan to accomplish their objectives.

Policy development, coalition, local allies. Most important that they talk with whomever is elected.

Tested the issue of I-25. Consultant interviewed Mostly supportive top donors and other community leaderships 95% supportive but question what business community can do to fix it. Need a five year funding program and need a media campaign editorial boards, need more media allies

Will develop a disciplined plan this fall
