

Monthly Report from CDPHE to the North Front Range Transportation and Air Quality Planning Council

July 2016

The Air Quality Control Commission:

- The Commission approved a request to hold an October hearing on the Division's proposal to revise the State Implementation Plan (SIP) for attaining the 2008 ozone standard.
- The Commission denied a request to stay its decision upholding the assessment of civil penalties against Sterling Ethanol, LLC and Yuma Ethanol, LLC

The Air Pollution Control Division:

- Ozone continues to exceed standards in the nonattainment area. Disregarding
 the three highest days at each monitor, raw data through July 2016 shows
 three sites exceeding 75 ppb and nine sites exceeding 70 ppb. Using the three
 year average of the fourth-highest daily value at each monitor, three sites are
 failing to attain the 75 ppb standard and five sites are failing to attain the 70
 ppb standard.
- CDPHE was selected as the state's Lead Agency to apply for and distribute approximately \$61 million from the nationwide partial settlement of claims against Volkswagen for their use of vehicle emissions "defeat devices."
 - The settlement must be approved by a federal court before it takes effect. The judge is expected to act in approximately October 2016.
 - If Colorado participates, the settlement would allocate approximately \$61 million to Colorado to reduce emissions of nitrogen oxides (NOx) from the transportation sector.
 - Depending on when the court acts, funds could be available as early as summer 2017. Colorado would have 10 years to submit projects for funding and 15 years to spend the funds.
 - Eligible projects include replacing or repowering certain medium- or heavy-duty trucks, buses, rail yard locomotives, airport ground support equipment, and forklifts. For most categories, the new or repowered vehicle may run on diesel, alternate fuel (e.g., CNG, propane or hybrid) or all-electric power. If the new or repowered vehicle is all-electric, the associated charging infrastructure is also eligible for funding. Up to 15%



- of the funds may be spent on light duty zero emission vehicle supply equipment (e.g., charging stations). The percentage of project costs eligible for funding depends on the type of project and whether the vehicle or infrastructure location is government owned.
- CDPHE is working with the NFR MPO and other agencies to determine how to select projects and allocate funds.







Remote Air Traffic Control Tower






The Program:

A cooperative effort with the FAA, funded by the State of Colorado to develop a cost effective alternative to construction of traditional airport traffic control towers. Colorado has contributed \$5.9 million toward the project.

Benefits:

- 1. Support increased safety, capacity and efficiency at non-towered airports;
- Avoid the cost associated with siting, designing, constructing, and maintaining a traditional Air Traffic Control Tower;
- 3. Allow enhanced airport traffic control to be within the reach of small and medium activity airports where Congressional earmarks provided funding in the past;
- 4. Provides a solution for maintaining safe separation from the emerging Unmanned Aerial Systems from manned aircraft.



Summary

- The Northern Colorado Regional Airport is transportation gateway for air travel.
- Local businesses use the benefit of time savings to compete in a fast paced, global economy.
- Critical emergency services support and disaster response are accommodated through the airport.
- ► FNL Airport is primarily funded by Airport revenues and State and Federal Grant programs through user fees derived from aeronautical use.

STAC Summary – July 29th, 2016

- 1) Introductions & June Minutes Vince Rogalski (STAC Chair) approved
- 2) Transportation Commission Report Vince Rogalski (STAC Chair)
 - a) HOV 2+ will change to HOV 3+ beginning on January 1st, 2017.
 - b) I-70 is in the midst of its busy summer season and thus far has maintained average speeds of 60 mph in the Mountain Express Lane and 45 mph in the general lanes.
 - c) CDOT conducted a Workforce of the Future assessment to identify the future skillsets, technologies, and training needed to prepare its workforce for the changing transportation landscape.
 - d) CDOT will present to the STAC next month on plans to conduct a Road Usage Charge (RUC) pilot.
- 3) **TPR Reports –** *TPR Representatives*
- 4) Grants Update Debra Perkins-Smith (CDOT Division of Transportation Development)
 - a) CDOT was awarded a \$15 million TIGER grant for improvements between SH 14 and SH/CR 402, including a new managed lane, park and ride, and trail connection. Local community contributions totaling \$25 million likely played a role in the success of the application. The total project cost is \$237 million.
 - b) Applications for the Federal Lands Access Program (FLAP) have been scored and a short list has been identified. Thad Noll will provide an update on the selected projects at the next STAC meeting.
- 5) Bicycle and Pedestrian Program Betsy Jacobsen (CDOT Multimodal Planning Branch)
 - a) CDOT's Bicycle and Pedestrian Policy 1602 was passed in 2009 and readopted by the TC in 2016.
 - b) CDOT takes a "5E" approach to bicycle and pedestrian issues: engineering, education, enforcement, encouragement, and evaluation/planning.
 - c) CDOT is supporting the Colorado Pedals Project aims to make Colorado the best state in the nation for biking, through infrastructure projects, public outreach, and internal culture change.
 - d) Colorado Beautiful seeks to ensure that within one generation, every Coloradan lives within a 10 minute walk of a trail, green space, or park.
 - e) CDOT is working with CDPHE to develop a Main Streets Guide as a communications and education tool for communities whose main street is also a state highway, laying out the options for future improvements. CDOT will complete the guide by the end of August and will share it with local communities statewide.
 - f) <u>STAC Discussion</u>: Currently the regulation of e-bikes varies significantly between communities, creating inconsistencies and confusion. A more statewide approach could offer significant benefits to Coloradans looking to adopt this new technology. CDOT should also work to address the issue of equestrian and ORV usage of bike and pedestrian trails given their use in agriculture and recreation.
- 6) **FHWA Alternative Fuel Corridors –** *Mike King (CDOT Multimodal Planning Branch) & Wes Maurer (Colorado Energy Office)*
 - a) The FAST Act requires FHWA to designate national Alternative Fuel Corridors by December 1st, 2016 and is soliciting state and local agency nominations for inclusion that are due by August 22nd, 2016.
 - i) Currently there are no dedicated funds attached to this program.
 - b) Nominations are limited to National Highway System (NHS) including 20 pages total identifying corridor name, geographic limits, surrounding populations, demographics, and economics, existing and planned alternative fuel infrastructure, and proven interest by stakeholders and the public.
 - c) Final designations will be based on the following criteria: 1) alternative fuels facilities (existing and planned), 2) corridor scale/impact, 3) emissions reduction, and 4) team development/collaboration.
 - d) CDOT proposes nominating the Colorado Energy Office's (CEO's) already identified "Tier 1" alternative fuel corridors, with potential additions as suggested by the STAC.
 - e) <u>STAC Discussion</u>: Some STAC members would like to form a working group to discuss the program and decide on the final list of corridors to nominate.



- 7) National Multimodal Freight Network Jeff Sudmeier & Jason Wallis (CDOT Multimodal Planning Branch)
 - a) The USDOT is soliciting nominations for the National Multimodal Freight Network (NMFN), due by September 6th, 2016 and there are no dedicated funds attached to this program.
 - b) The NMFN was established by the FAST Act and includes the National Highway Freight Network (NHFN) discussed at last month's STAC plus Class I railroads, significant ports and waterways, and 50 airports with the highest annual landed weight (in Colorado, only DIA qualifies).
 - c) The federal government has selected primary highway routes for inclusion, while CDOT may select up to 600 miles of rural highway or rail corridors considered most important to freight movement.
 - i) Criteria set by CDOT include: 1) Truck AADT > 500, 2) % Truck > 10%, 3) Connectivity
 - ii) Using this method, CDOT has identified over 2,600 corridor miles, but can only select 600.
 - d) CDOT is soliciting input from STAC, TRAC, and TC and will review its recommended nominations at the August STAC meeting.
 - e) <u>STAC Discussion</u>: CDOT should also consider nominating key intermodal facilities as part of this effort. The potential corridors identified via the 3 criteria analysis overlap with those identified as the Colorado Freight Corridors in CDOT's 2015 State Highway Freight Plan.
- 8) Truck Parking Jeff Sudmeier & Jason Wallis (CDOT Multimodal Planning Branch)
 - a) CDOT is also working on the topic of truck parking, identified by the Colorado Freight Advisory Council (FAC) as the #1 freight issue for CDOT to address.
 - i) When we talk about truck parking we don't just mean spaces, but safe and comfortable facilities.
 - ii) Jason's Law allows for greater regulatory and funding flexibility to support truck parking.
 - b) Hours of Service violations are a big consideration here, making sure that drivers have spaces available when and where they need to stop.
 - c) CDOT conducted a statewide truck parking study in 2007 and plans to do a follow-up in 2016, examining the regulatory, business, and political factors at play.
 - d) CDOT will also conduct a truck parking management (TPM) assessment and partner with neighboring states to develop a multi-state approach.
 - e) <u>STAC Discussion</u>: The idea of using chain stations as temporary truck parking facilities during the summer months with be investigated further. Wireless and 4G access is an important amenity that shouldn't be overlooked.
- 9) SB 228 / Bustang / Rural Regional Bus Plan David Krutsinger (CDOT Division of Transit & Rail)
 - a) Review of the Rural Regional Bus Plan, to be funded with SB 228 transfers:
 - i) Phase 1 Extend Bustang service to Grand Junction and bolster regional routes to Steamboat Springs and Durango.
 - ii) Phase 2 Re-bid 5 regional routes under one provider, brand, and fleet.
 - iii) Phase 3 Establish additional regional routes (currently unfunded but seeking partnerships).
 - b) <u>STAC Discussion</u>: The STAC votes to recommend TC approval of CDOT's Rural Regional Bus Plan (Phases 1-3).
- 10) STAC Workshop and Elections Vince Rogalski (STAC Chair)
 - a) The STAC Workshop will be held on September 23rd, and the draft agenda is included in this month's STAC packet for comment.
 - b) <u>STAC Discussion</u>: STAC members would like to invite all members of the TC to participate, rather than just the TC Chair. They consider this more in-line with the intent of the state legislation clarifying the relationship between the STAC and TC. Representative Terri Carver, the bill's sponsor, has also been invited to participate.
- 11) Other Business Vince Rogalski (STAC Chair)
 - a) A reminder that CDOT will be hosting a training webinar on recent changes and documentation for the TPRs' Rural Planning Assistance (RPA) grants all TPR chairs and administrators are encouraged to participate.
 - b) The next STAC meeting will be held on Friday, August 26th, 2016.
