Members discussed the importance of travel training before seniors need to give up car. <u>LC Senior Transportation</u> – The RFP for the Larimer County Senior Transportation Needs Report was sent out, and there is a meeting to review RFPs.

Discussion Items

PFAC SYMPOSIUM	The Larimer County PFAC will hold a symposium on September 22 at the Fort Collins Senior Center. STC Members discussed what the STC has accomplished to write a 150-word description. Martin will provide pictures. Members discussed who should present, as it should be someone involved in STC but not on the PFAC. Katy provided a list of accomplishments, on-going projects, and proposed projects. Potential future projects were discussed, including a Bustang travel training, night service to cultural events, data collection of travel training users. Alex will provide a summary of these accomplishments for edits and STC member approval.
LARIMER COUNTY SENIOR TRANSPORT STUDY	Katy handed out the RFP to show the importance of STC to the overall needs assessment. STC members should reach out to Wellington for their inclusion. The selected consultant will attend STC meetings in the future. There should be more representation from the east side of I-25. Members all discussed potential services the consultants should research, including the Liberty app, ITN, and the National Volunteer Transportation Centers.
