- 1. Introductions
- 2. Review of Agenda There were no changes to the agenda.
- **3. Public Comment** (Non-Agenda Items) Steve Teets announced there would be a movie showing on March 16.
- **4. Approval of Meeting Notes** (October) No edits to December meeting notes. Celeste motioned to approve the meeting notes and Libby seconded the motion.

#### 5. Discussion Items

<u>Tour</u> - Celeste Ewert, Executive Director of Envision, provided background on Envision. The organization began in 1694 and currently serves more than 2,000 families per year. To be eligible, a person must have a delay of a certain percentage and miss a certain number of milestones. The family or doctor can refer. Envision offers a Child Extensive Support program, for children between 3 and 18 years old, and Adult programs for those over 18. These programs are day programs, can be specialized, integrated or not integrated, and can be group supported employment. Envision provides case management for its members. Celeste explained Envision is a personcentered agency, which means the organization provides individualized care, not group plans. Colorado recently passed a Conflict Free Case Management law, which prohibits the delivery of Case Management Support and Home and Community Based Direct Services by the same agency or entity. Envision operates 34 vans, owning about 5 or 6 of them and leasing the rest. The City of Greeley provides a grant to offset transportation costs for transporting residential and day programs. Additionally, Envision members can use paratransit or the GET system, using bus passes.

<u>Transportation Providers</u> - Steve discussed issues with mobility in Weld County. Recently, two taxi companies have shut down but we should remain focused on mobility because transportation options are limited.

<u>2045 RTE</u> - Alex presented information about the <u>2045 Regional Transit Element</u> that the NFRMPO is undertaking. It builds on work done for the <u>2017 Coordinated Public</u>

Transit/Human Services Transportation Plan, but expands the time horizon and looks at improving transit for all populations.

<u>GET</u> - Leighton Powell is the new Transit Operations Supervisor at GET. The Regional Route Study is progressing, and will be presented to the Fort Collins City Council.

#### 6. Committee Member Reports

Libby stated overnight shelter is available.

Steve discussed the need for transportation between Loveland and Greeley.
