Discussion Items

LARIMER COUNTY SENIOR TRANSPORTATION WORK GROUP UPDATE	Alex explained the background for two key grants, NADTC and the §5304 projects. Three interviews for the 5304 grant consultant were held on March 26, 2019 – one has been chosen and is going through the contracting phase. Alex will let people know who the winner was once the contract is signed. A webinar was held to provide information on the NADTC grant on April 4, 2019.
FCBIKES	 Jamie Gaskill presented about the Bicycle Ambassadors Program (BAP). BAP was formed in 2012 as a regional collaboration but was merged into FCBikes, which is a division of FCMoves, the transportation department of the City of Fort Collins. There are approximately 117 Bicycle Ambassadors who assist the program carry out the 5 "E"s: education, encouragement, enforcement, engineering, and evaluation. Jamie has been working with the Fort Collins Police Department to train patrol officers on laws related to cycling. The Bicycle Friendly Driver program has caught on nationwide, leading to Jamie getting recognized at the National Bike Summit. Forty-seven states and 5 countries have implemented a form of the program based on a toolkit designed by Jamie. Anna noted all Transfort drivers are trained as part of this program. Four new programs are being rolled out: Bike Buddy – one-on-one training sessions with Bicycle Ambassadors Bike Fix-It Bonanza – basic maintenance and other bicycle-related event on April 27 at five locations Borrow our Bike Ambassadors – customized programming including Bicycle Ambassadors Proposed E-Bikes pilot – one year pilot starting May 1, 2019 to allow e-bikes on trails (15 mph speed limit) The group suggested Jamie reach out to physical therapists, Aspen Club, 50+Marketplace, Chris Atib, PAFC's Health and Wellness Priority Group, Los Ancianos Unidos, and other bilingual groups.
