### 1. Call Meeting to Order, Welcome and Introductions

#### 4. Approval of February 26, 2019 Meeting Minutes

Celeste motioned to approve the minutes with a correction that the February meeting was held at Frontier House, not the Greeley Center for Independence. Julie seconded the motion and it was approved unanimously.

#### **DISCUSSION ITEMS**

#### 1) Rider's Guides

Alex handed out Rider's Guides with updates from the previous meeting. Comments included removing some superfluous language, adding in the El Paso-Los Angeles Limousine Express buses, clarifying Bustang weekend schedules, and making sure the handicap symbol is more obvious on the transportation provider's headline.

#### 2) 2045 RTE Survey Report Out

At the previous meeting, Steve provided Alex with additional surveys initially undertaken during the 2045 RTE. Alex analyzed the answers and the data and provided a handout showing responses by zip code. The major themes included the need for better frequency, coverage including regional connections, accessibility, school/student issues, and overall security. Leiton provided feedback about GET's efforts to address each of these concerns. In terms of accessibility, GET provides travel training allowing wheelchair users to practice getting their wheelchairs onto and off the bus. GET is working with law enforcement to address security and safety issues as they are reported. Requested connections were from major Weld County towns within the NFRMPO region to other communities, Denver, Colorado Springs, and to recreational spots in Weld and Larimer County.

Gordon 3) Larimer County Senior Transportation Project Update Alex provided an update about the project and mentioned Weld County should be involved. He will bring back ideas of how to keep Weld County communities involved.

#### **GREELEY-EVANS TRANSIT NEWS AND UPDATES**

Leiton provided an update on the Poudre Express. Drivers tested the route and it is currently running at 80 minutes, instead of the promised 75 minutes. Staff is currently working with other communities on funding. The fare is expected to be \$1.50, similar to other GET routes. Other potential funding sources are the cities of Fort Collins and Greeley, Town of Windsor, and Colorado State University.
