Discussion Items

LARIMER COUNTY SENIOR TRANSPORTATION WORK GROUP UPDATE	The §5304 grant consultants presented case studies about different Mobility programs from around the country. They will take a closer look at Cambridge Systematics. Advice from the agencies included having a dedicated Mobility Manager, not starting too big, and being customer focused. The next steps are answering the question of who hosts the programs and the different scenarios of what that may look like. The next meeting could be in August depending on the need. The NADTC grant was expected to provide funding for rides through July 31 but the grant was extended through October. There is a meeting at the end of August to discuss the project. As of the end of July, there were 259 rides and 35 participants. Rides have been extended through August 16.	
N4A CONFERENCE REPORT	Alex recapped the conference and discussed the potential partnerships and possibilities. It is important to get the right people at the table.	
BUSTANG TRAVEL TRAINNGI	Alex and Brooke provided an update on the Bustang travel training. Bustang could potentially get a bus for the training. There are questions regarding interpreters and technology, who the focus is, how big of a group it should be, and what agencies are involved. Alex and Brooke will follow up.	
CARFIT EVENT	Jill provided an update on the CarFit event. The focus is on older adults and figuring out if the car they have is the right fit for them. It is sponsored by the Aspen Club. It is free and volunteer-run. It will be held October 14 from 9 a.m. to 12 p.m. at Lifepoint Church. There will also be a Transportation Fair with booths, tents, and goodie bags. They are hoping for 100 volunteers. Outreach is currently being done to promote the event because registration is required. Booths should be set up by 8:40 on the day of the event.
