Discussion Items

LARIMER COUNTY SENIOR TRANSPORTATION WORK GROUP UPDATE	Alex gave an update about the two projects, including background for the new people at the table. Suzanne noted some issues with the Trip Planner, where it gives a roundabout set of directions rather than a simpler set. The directions make people transfer and include long walks. The group discussed the CDOT Consolidated Capital Call for Projects (CCCP). In the future, it may be possible to use volunteer driver time as local match to get operating grants.
BUSTANG TRAVEL TRAINING	Alex noted Maria has left Bustang and he will contact Mike Timlin for permission to use a Bustang bus. Alex and Brooke will follow up about a Spanish travel training. There should be a destination for the training to make it more understandable and real world-oriented.
CARFIT EVENT	The event was canceled. The group discussed whether they should hold another CarFit event. The group decided to begin looking into a Transportation Fair/forum, which could include healthcare professionals and other people who need to learn about transportation options.
OTHER OUTREACH	<p>Alex noted the NFRMPO is beginning to work on the EJ Plan, which could incorporate the Health Equity Index and the Multimodal Index. There should be a focus on outcomes, making the planning process “human oriented”, performance measurement, and mobility hubs.</p> <p>The group discussed IntelliRide issues, which could be an argument to bring NEMT trips back into the County.</p>

Member Updates

CONNIE	SAINT had its data transferred to Spedsta and so far it is looking good. Connie is following up with Spedsta. The goal is to have the technology ready by October, including training and customization.
ANNA	Transfort is unveiling a new marketing campaign called “Yield to the Bus” and “Have a heart, drive smart”. Anna has been doing travel trainings, including at

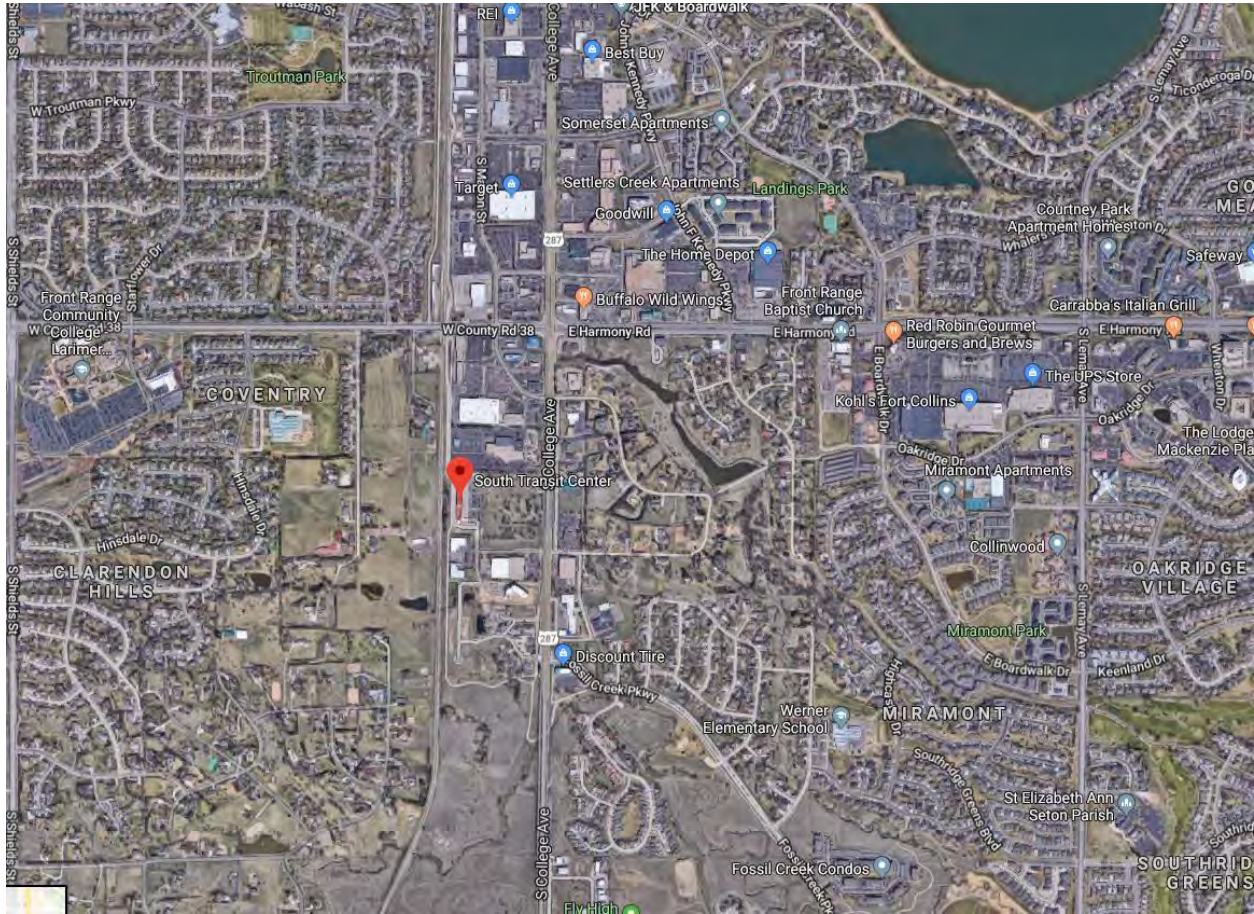
	the Chilson Center in Loveland.
BROOKE	The Built Environment team is hosting “Planning with People First” on October 25 th in Longmont. They received a grant for water quality in Parklane and other mobile home parks. They completed 200 “Mi Voz” panel surveys. They are doing more experiential walking tours, with the next one at Silverleaf in Loveland.
SUZANNE	The Senior Advisory Board has had the Fire Department come speak, including about a local program going to senior homes beyond checking/fixing smoke alarms.
SHARON	Sharon has joined a lobbying group. She is looking for ideas of what Larimer County priorities are. Emergency management has come up, and she wondered how transportation fit into that.
