1. Call Meeting to Order, Welcome and Introductions

2. Review of Agenda

Gordon stated Tim McLemore from Elderhaus is not able to present. Gordon asked each member to introduce themselves and how their agency is reacting to COVID-19.

- Transfort Russo reported transit centers are closed, but buses are still operating a normal weekday schedule. The Poudre Express was canceled because of the weather.
- Town of Berthoud The Town has been closed to the public since Tuesday. Staff are alternating shifts to maintain social distancing.
- Foothills Gateway Foothills Gateway is closed for Spring Break, and staff will be working from home when it reopens next week. There will be limited programming and transportation offered.
- RAFT Berthoud Senior Center and Community Center are closed. PAFC volunteers may elect to reduce their hours and riders have been alerted to the potential reduction in service. RAFT is not providing rides to seniors, only adults with disabilities. RAFT has started a credit account with zTrip to provide rides RAFT cannot, based on a relationship started with the NADTC grant.
- The Arc of Larimer County Arc offices are open, but staff are working from home. Events have been delayed. Advocacy is still happening.
- SAINT Ride purposes have been restricted to essential trips, e.g. work, grocery, and medical. There is a reduced number of drivers, but SAINT is still open. SAINT is screening riders who may be symptomatic, and declining rides to are.
- Division of Voc. Rehab Staff has been encouraged to work from home but maintaining minimum staffing in the office. Voc. Rehab is actively taking new intakes, but there are not too many companies hiring. Grocery stores are hiring.
- Office on Aging The Office on Aging is working from home. Phones are being monitored and calls returned, but no in-person services. The LCOA is working with providers to transportation symptomatic patients. LCOA has ordered boxes of food for distribution.



- zTrip zTrip is still operating paratransit in Fort Collins and Loveland. There is a heightened cleaning and disinfecting protocol for transporting sick riders. Ridership is down. zTrip is reaching out to Medicaid for permission to transport food and necessities without the PAR riders.
- PAFC Jim is working from home.

The group asked that the NFRMPO distribute information and updates as they receive them. Brown asked if there is a resource for people who are symptomatic to know what agencies will transport them. Mason responded the Office on Aging is working with a provider to get them to transport older adults.

4. Approval of November 21, 2019 Meeting Minutes

Woodall moved to approve the meeting minutes. Russo seconded the motion, which was approved unanimously.

DISCUSSION ITEMS

1) One Call/One Click Center Project Update

Gordon stated the Larimer County Board of County Commissioners adopted the <u>Larimer County Senior Transportation Implementation Plan</u> in November 2019. The project was taken to the NFRMPO Planning Council in November and December 2019, and funding was approved in January 2020. NFRMPO staff is awaiting contracting with CDOT to hire the Mobility Manager. The project has been discussed in Weld County and there is support. No funding exists for the area outside the NFRMPO boundary, which is something that will need to be addressed. Senior Transportation Coalition (STC) will now be known as the Mobility and Access Priority Group (MAPG) and will act as the outreach team for the One Call/One Click Center project.

Fletcher-Carter stated she and Adam Laso from BATS met with 60+ Ride in Weld County to discuss the Ride Scheduler program. Fletcher-Carter will be asking if the program is compatible with the OCOCC.

2) 2020 Work Plan

A draft work plan was included in the meeting packet. New topics include adapting to COVID-19, safety and health, and discussing customer service and program standards.

3) Environmental Justice Plan

Gordon introduced the EJ Plan. Brown recommended using postcards as a non-online approach. Russo suggested working with Neighborhood Services and the Barriers to Transit working group. Th need to tie land use and transportation together are important. Mason recommended reaching out to La Familia and Holy Family Church.

4) Legislative Report

The group liked the legislative report and want to receive it in the future.

We are early in the plan development process, collecting data from our partners on existing conditions, planned projects, and community visions. We will be ramping up our public outreach efforts soon. We anticipate adopting the Plan in early 2021.






Regional Active Transportation Plan

 - Updated and expanded on the 2013 Regional Bicycle Plan
 - Expanded the focus to include pedestrian travel
