2022 Regional Mobility Action Plan

Overview:

The Larimer County Mobility Committee (LCMC) and Weld County Mobility Committee (WCMC) worked with the North Front Range Metropolitan Planning Organization (NFRMPO) on the update to the [2021 Coordinated Public Transit/Human Service Transportation Plan \(Coordinated Plan\) to improve the mobility of older adults, individuals with disabilities, and low income individuals in Northern Colorado](#). The plan identified 5 strategies to address the mobility needs of these population to improve access, mobility, and quality of life in our communities: **Coordination, Education, Collaboration, Infrastructure/Funding, and Non-Mobility Improvements**. To continue the momentum of the Coordinated Plan planning process, the mobility committees have brainstormed goals and action items (listed below) to address these strategy areas in 2022 and beyond as outlined in this *Regional Mobility Action Plan*.

2022 Goals:

1. Create a shared resource library
2. Educate LCMC/WCMC members on transportation programs/options available
3. Educate community members of Larimer and Weld Counties on availability of transportation options
4. Direct providers to existing state and regional driver training programs
5. Compile an inventory of current mobility infrastructure and voucher programs
6. Identify new funding sources
7. Create a recruitment working group to increase interdisciplinary participation, including from the healthcare system, in mobility committees.

Working Groups

Two working groups will meet in 2022 during WCMC and LCMC meetings or as determined by the working groups. These include:

Recruitment Working Group:

Mission (proposed): The Recruitment Working Group will coordinate strategies and activities to increase membership and participation in the mobility committees, with a focus on increasing membership from interdisciplinary professions such as healthcare and active transportation with a focus on equity.

Working Group Lead: Cory Schmitt, NFRMPO

This working group with focus on the following goal:

7. Create a recruitment working group to increase interdisciplinary participation, including from the healthcare system and active transportation, in LCMC and WCMC

Outreach and Education Working Group:

Mission (proposed): The Outreach and Education Working Group will coordinate strategies and activities to increase the awareness of transportation providers and programs in Larimer and Weld Counties.

Working Group Lead: Hanna Johnson, NFRMPO

This working group with focus on the following goals:

2. Educate LCMC/WCMC members on transportation programs/options available
3. Educate community members of Larimer and Weld Counties on availability of transportation options

Collectively the LCMC and WCMC will advise on the following goals on an as-needed basis:

1. Create a shared resource library
4. Direct providers to existing state and regional driver training programs
5. Compile an inventory of current mobility infrastructure and voucher programs
6. Identify new funding sources

Strategy 1: COLLABORATION

Local transportation providers, human service agencies, stakeholders, and other community groups will work together to reduce barriers for access to transportation. An example of this strategy is RideNoCo, the NFRMPO's One Call/One Click Center program.

Goal 1: Create a shared resource library.

Summary: The Shared Resource Library would serve as an online resource to transportation providers to share resources, information, and build off one another's work. All transportation providers would contribute the documents requested by the Project Lead. The Project Lead would ensure the library stays up to date, organized, and add documents as requested by transportation providers. This goal was prioritized third (tied with Goal 6) during the March 2022 Joint Mobility Committee meeting.

Action Steps

- Identify a preferred shared platform
- Identify documents and resources transportation providers want to share
- Compile documents and resources
 - Policies and procedures
 - Eligibility Forms for human service and paratransit service providers
 - Legal and Policy Resources for transportation providers (FTA, CDOT policies, Title VI, ADA, etc.)
 - Route and Location Information
 - Maps of Routes/GIS Data
 - Fleet and Service Information – number of vehicles, number of volunteers, number of employees, etc.
 - Training materials
 - How to work with people with disabilities
 - Unruly passengers
 - Informational brochures
 - Contact Information for agency
- Train WCMC/LCMC Members on how to access and navigate Shared Resource Library
- Keep library updated and relevant, ensure new WCMC/LCMC members have access to library
- Create handbook on how to manage Shared Resource Library as people and positions change
- Spread the word about Shared Resource Library to all transportation providers and WCMC/LCMC members

Strategy 2: EDUCATION

Disparate programs exist for vulnerable populations to meet their basic needs, so there should be an investment in travel training, cross promotion, and proactive educational campaigns like the Rider's Guides to help educate the community on potential transportation options.

Goal 2: Educate WCMC and LCMC members on transportation programs/options available

Summary: Increase understanding within WCMC and LCMC members of transportation programs and options available. This goal was prioritized fourth during the March 2022 Joint Mobility Committee meeting.

Action Steps

- Have 5-minute presentations by members and invited partners at each meeting
 - Members specifically requested the following agencies to present information to the mobility committees:
 - CASTA
 - IntelliRide
- Invite new partners in related topic areas to present to WCMC and LCMC
- Compile training and informational materials for WCMC and LCMC members
 - This could be stored in the Shared Resource Library
- NFRMPO train agency staff and volunteers how to use RideNoCo website and when to refer clients to RideNoCo staff as appropriate
- Ensure information is accessible and up to date on the Shared Resource Library

Goal 3: Educate community members of Larimer County and Weld County on availability of transportation options.

Summary: Increase understanding and awareness of Larimer and Weld community members of transportation programs and options available. Conduct outreach as possible and coordinate outreach to share materials for the variety of transportation options available. This goal was prioritized as first during the March 2022 Joint Mobility Committee meeting.

Action Steps

- Distribute Rider's Guides
 - o Both within LCMC and WCMC committee member organizations/agencies and within the community
 - o Distribute to health clinics
- Host RideNoCo staff to present to organizations/agencies serving clients who may have transportation barriers
- Coordinate Travel Trainings with RideNoCo staff
- Add RideNoCo links/branding to existing outreach channels
 - o Website, social media, etc.
 - o Add link to RideNoCo website on email signatures
- Regularly check in with providers to ensure website, Rider's Guide, and Provider's Guide has up-to-date information
- Add current transportation brochures and program materials to Shared Resource Library for all members to reference/distribute as desired
- Create informational fliers and mailings to distribute
- Conduct outreach to community. A few suggested groups/agencies to reach out to include:

Strategy 3: COORDINATION

Similar to collaboration, transportation providers, human service agencies, stakeholders, and other community groups work best when they work together. These face-to-face or digital networks can make it easier to share strategies and address regional needs. Examples include the Larimer County and Weld County Mobility Committees, which each meet bi-monthly.

Goal 4: Direct transportation providers to existing driver training programs.

Summary: Via Mobility Services currently provides CDL and non-CDL driver training programs to other agencies in the region. Direct transportation providers in Larimer and Weld Counties to this training program as needed. This goal was prioritized as sixth (last) during the March 2022 Joint Mobility Committee.

Action Steps

- Assess need for training
- Provide connection to Via Mobility training program

Strategy 4: INFRASTRUCTURE AND FUNDING

Additional funding and service is important to addressing goals. Programs like Dial-a-Taxi, new and replacement vehicles, and local assistance to apply for new grants can be useful tools to improve service for vulnerable populations.

Goal 5: Compile an inventory of current mobility infrastructure and voucher programs.

Summary: By compiling an inventory of current “hard” and “soft” mobility infrastructure, LCMC/WCMC members can better assess how to coordinate existing resources and apply for new resources through grant applications in future years. This goal was prioritized as fifth during the March 2022 Joint Mobility Committee.

Action Steps

- Create survey for transportation providers to fill out
- Invite voucher programs to present to mobility committees; save presentations to Shared Resource Library
- Create format to track/record information
- Compile number of vehicles and vehicle type of transportation providers in Larimer/Weld Counties
- Compile number of volunteer drivers currently active
- Compile paid driver openings and number of current paid drivers
- Compile list of inventory/infrastructure needs and needed upgrades
- Compile organizational charts of transportation providers to gauge organizational capacity
- Provide information to Larimer County and Weld County Offices of Emergency Management

Goal 6: Identify new funding sources.

Summary: Research and report out potential funding sources for WCMC/LCMC members to improve mobility options and outcomes in Larimer and Weld Counties. This goal was prioritized as third (tied with Goal 1) during the March 2022 Joint Mobility Committee.

Action Steps

- Compile list of current funding sources (public, private, donations, etc.)
- Identify funding gaps for transportation providers
- Identify new funding sources, including public and private grants that may fill gaps or meet collective goals
- Report funding sources to group and coordinate any collaborative grant opportunities
- Invite potential funders to LCMC/WCMC meetings to present on their funding source and application process

Strategy 5: NON-MOBILITY IMPROVEMENTS

Bureaucracy can stand in the way of best addressing the needs of vulnerable populations. Strategies like addressing transportation access during zoning, identifying options for active transportation to address public health concerns, and other non-transportation focused strategies can help reduce demand for specialized services and increase access to the community.

Goal 9: Increase health care industry and interdisciplinary participation in LCMC and WCMC through a Membership and Recruitment Working Group.

Summary: Invite more voices to the table at WCMC and LCMC meetings. This goal was prioritized as second during the March 2022 Joint Mobility Committee.

Action Steps

- Create Membership & Recruitment Working Group
- Recruit and engage at least one member from the following professions/agencies:
 - Active transportation
 - Veterans services
 - Non-profits serving low-income individuals
 - Non-profits serving the houseless community
 - Non-profits serving people who do not speak English as a first language.
 - Land use and development profession
- Create list of potential agencies and organizations to recruit to committees
 - Suggested organizations include:
 - Federally Qualified Health Centers (FQHC)
 - Municipal and County Governments
 - Libraries
 - Veteran's Organizations
 - Nutritional Services
 - Agencies and committees serving people with disabilities
 - Agencies and committees serving people who do not speak English as a first language, immigrants, or refugees
 - Agencies and committees serving people with low incomes and people experiencing houselessness

 - Potential Contacts:

3. Public Comment (2 minutes each)

Teets requested information on the Via Service in Frederick and Firestone, as well as the Via Pilot in southwestern Weld County. Schmitt noted that the Firestone and Frederick was independent of the Pilot and will continue; he also noted that the Via Pilot in southwestern Weld County is set to end in February, and partners are working to find funding to continue Via service in southwestern Weld County. NFRMPO staff will likely have more information to share about the SW Weld Via service at the next meeting. Teets also requested that at the October 2022 Joint Mobility Meeting, NFRMPO Staff invite Boulder County MAC representatives.

4. Approval of December 2021 Meeting Minutes

Teets motioned to approve the December 2021 minutes. Martinez seconded the motion, and it was approved unanimously.

RIDENOCO UPDATES

Schmitt gave an update about RideNoCo, including the following updates:

- 1) Phase I: Website and Call Center launch – Complete in 9/2021. Roughly 750 visitors to the website in 2021
- 2) Phase II: Trip Discovery Tool – delivery in 2022. This will allow people to find and plan trips on the RideNoCo website and will utilize GTFS-Flex Technology to allow volunteer providers to be shown in addition to public transit agencies. IBI Group was selected to complete this project.



- 3) Phase III: Trip Dispatching– delivery in 2023. This will empower providers and riders to find, book, and pay for a ride in one place. The Trip Scheduling Steering Committee will guide this phase with a consultant being brought onboard to facilitate this Committee.
- 4) Trip Scheduling Steering Committee:
 - a. Includes: 60+ Ride, SAINT, RAFT, Via, GET, BATS, Foothills Gateway, Arc of Weld County, Red Feather Lakes, CO Div. of Vocational Rehabilitation, LCOA, Weld County AAA

ACTION ITEM

- 1) **Co-Chair Elections** – Teets nominated Ewert to co-chair. Ewert nominated Bedingfield to the other co-chair. Barzak noted that the current chairs, Ewert and Bedingfield, have both served the committee well. **Ewert and Bedingfield were unanimously re-elected into the co-chair roles.**

- 1) **2022 Work Plan** – All attendees were split into small groups (four virtual groups and one in-person group) to discuss the 2022 WCMC Work Plan. Each group focused on a strategy area from the [2021 Coordinated Plan](#) and made notes for their small group discussion in a [Google Document](#). NFRMPO staff and WCMC will further refine and prioritize activities for the Work Plan at future meetings. Discussion specifics can be found in the google document referenced.
