## **Bike & Ped Safety Reporter Tool**

Since Summer 2022, NFRMPO and regional partners have launched the Bike & Ped Safety Reporter tool. This crowdsourced reporting tool supplements crash data and identifies areas in the region where individuals feel unsafe while using active transportation (bicycles, escooters, walking). Often, parts of the transportation system are only deemed unsafe after a crash happens. This tool gives the



general public the ability to report hazards from people walking, biking, or rolling.

**Severance Walk Audit** 

On August 10th, 2022, the Northern Colorado Bike & Ped Collaborative conducted a walk audit of the Town of Severance.

More than 20 members of the community representing agencies such as the North Front Range Metropolitan Planning Organization (NFRMPO), the City of Fort Collins, Weld County Department of Public Health & Environment, Colorado Department of Public Health & Environment (CDPHE), Envision, Weld County Department of Public Health and Environment, and Cycling Without Age participated in the 2 hour assessment.

Participants split into two groups to assess walkability and accessibility in and around Downtown Severance and along the Great Western Trail. One group started the audit on the Great Western Trail while the other group began in Downtown Severance.





In addition to taking notes with pen and paper, each group documented the pedestrian experience utilizing the newly created NFRMPO Bike & Pedestrian Safety Reporter Tool. In total, 33 unique reports were made using this tool during the audit.

The NFRMPO published an ArcGIS Online Story Map summarizing the feedback and photos provided through this walk audit. Severance Walk Audit Story Map

### **Fare Free Transit Month Recap**



During the month of August in 2022, public transit agencies across the state of Colorado joined together to take part in the Zero Fare for Better Air initiative. Colorado implemented a one-month pilot program of zero-fare transit across the state. Northern Colorado transit agencies such as COLT and GET participated. Transfort did not participate as its services have been fare free since the beginning of the pandemic. Not only did this lead to an increase in ridership across all of the participating transit agencies, but it also helped to reduce CO2 emissions, increased access to goods and services, and saved riders money on gas helping to further preserve the Colorado way of life. Both COLT & GET reported ridership levels for August 2022 that were at-or-above prepandemic levels.

This program, managed by the Colorado Association of Transit Agencies (CASTA) in partnership with the Colorado Energy Office (CEO) was made possible by funding dedicated by the state legislature through SB22-180. Ann Rajewski, Executive Director of CASTA said, "Transit plays such an important role in our state from connecting people to employment, education, and services to helping reduce air pollution by providing people with cleaner travel options."

## **Bustang Service Announcement**

Beginning on September 6th, CDOT's statewide transit service Bustang added 2 additional daily round trips on the North line serving Fort Collins, Loveland and Denver (see schedule below). Service information can be found at this
