### MPO MEETING PROCEDURAL INFORMATION

1. The order of the agenda will be maintained unless changed by the MPO Planning Council Chair (MPO Chair).

2. "Public Comment" is a time for citizens to address the Planning Council on matters that are not specifically on the agenda. Each citizen shall be limited to a total of two (2) minutes time for public comment, or at the discretion of the MPO Chair.

3. Before addressing the Planning Council, each individual must be recognized by the MPO Chair, come and stand before the Council and state their name and address for the record. (All proceedings are taped.)

4. For each Action item on the agenda, the order of business is as follows:

- > MPO Chair introduces the item; asks if formal presentation will be made by staff
- Staff presentation (optional)
- > MPO Chair requests citizen comment on the item (two minute limit for each citizen
- Planning Council questions of staff on the item
- Planning Council motion on the item
- Planning Council discussion
- Final Planning Council comments
- Planning Council vote on the item

5. Public input on agenda items should be kept as brief as possible, and each citizen shall be limited to two (2) minutes time on each agenda item, subject to time constraints and the discretion of the MPO Chair.

6. During any discussion or presentation, no person may disturb the assembly by interrupting or by any action such as applause or comments. Any side conversations should be moved outside the meeting room. Courtesy shall be given to all speakers.

7. All remarks during the meeting should be germane to the immediate subject.

Vice Chair James called the MPO Council meeting to order at 6:02 p.m.

#### Public Comment:

#### Move to Approve Agenda and Minutes

Heid **moved** to *APPROVE THE NOVEMBER 3, 2022 MEETING AGENDA AS SUBMITTED.* The motion was **seconded** by Canonico and **passed** unanimously.

Olson **moved** to *APPROVE THE OCTOBER 6, 2022 MEETING MINUTES AS SUBMITTED.* The motion was **seconded** by Canonico and **passed** unanimously.

#### Lead Planning Agency for Air Quality Agenda

Vice Chair James opened the Air Quality portion of the meeting.

#### **REPORTS:**

<u>Air Pollution Control Division (APCD)</u> A written report was provided.

<u>Regional Air Quality Council (RAQC)</u> A written report was provided.

#### NFRMPO Air Quality Program Updates

Bornhoft noted the EPA's reclassification of the Denver Metro/North Front Range Ozone Nonattainment Area is taking effect on November 7<sup>th</sup>. The Air Quality Control Commission will be holding a rulemaking hearing on the State Implementation Plan (SIP) in December. NFRMPO staff is working with CDOT and CDPHE on an Intergovernmental Agreement on greenhouse gas modeling. James asked about the role of the IGA, and Bornhoft provided clarification. James requested that the Council be given the opportunity to review the IGA as well.

#### Metropolitan Planning Organization (MPO) Agenda

Vice Chair James opened the MPO portion of the meeting.

#### **REPORTS:**

Report of the Chair

James stated the officer elections will be held in December and Director Mallette's evaluation is also in December.

#### **Executive Director Report**

Mallette noted there was a request from Commissioner Stephens to integrate the Colorado Transportation Investment Office (CTIO). Former Loveland Councilmember Cecil Gutierrez is the NFRMPO's representative on the CTIO Board. He will begin attending meetings in January to provide a report. CTIO minutes will be included in the Council packet.

<u>TAC</u> A written report was provided.

<u>Mobility</u> A written report was provided.

<u>Finance</u> A written report was provided.

<u>Community Advisory Committee (CAC)</u> A written report was provided.

#### Q3 2022 TIP Modifications

A written report was provided.

#### CONSENT AGENDA:

Rennemeyer **moved** to *APPROVE THE CONSENT AGENDA*. The motion was **seconded** by Canonico and **passed** unanimously. The consent agenda included one item:

• FY2022 TIP Delay Review

#### **ACTION ITEMS:**

#### Link NoCo Study Recommendations

Gordon outlined the recommendations of the study, including potential governing structures. Gordon stated the public comment period ended on November 5<sup>th</sup>.

Rennemeyer **moved** to approve the *NORTH FRONT RANGE LINK NOCO STUDY, RESOLUTION NO. 2022-31 as* presented. The motion was **seconded** by Olson and **passed** unanimously.

#### **Records Retention Policy**

Mallette noted the NFRMPO has never had a record retention policy. The policy is based on state schedules using areas that pertain the MPO. NFRMPO staff reviewed the policy and recommended extending the retention period for fleet dispositions and TAC meetings.

Heid **moved** to approve the *RECORDS RETENTION POLICY*. The motion was **seconded** by Mallo and **passed** unanimously.

#### NFRMPO FY2023 Budget Amendment #1

Mallette outlined the proposed budget amendment which will allocate an additional \$90,000 for NFRMPO staff salary adjustments, \$30,000 for modeling, \$37,000 for air quality work, and \$10,000 for IT. This was reviewed and recommended for approval by the Finance Committee.

Canonico **moved** to approve the *NFRMPO FY2023 BUDGET AMENDMENT #1, RESOLUTION NO. 2022-32 as* presented. The motion was **seconded** by Mallo and **passed** unanimously.

#### **DISCUSSION ITEMS:**

#### 2022 Public Involvement Plan (PIP)

Cunningham outlined the contents of the <u>Public Involvement Plan (PIP)</u> which is federally required and updated on the same cycle as the <u>Regional Transportation Plan (RTP)</u>. The plan covers all NFRMPO activities, including the RideNoCo program. The plan has four guiding principles: Meet people where they are, provide options for involvement and be adaptable, be a good community partner, and consistently evaluate throughout the public outreach process. Existing strategies include online media such as the NFRMPO website, social media, and newsletters. Lessons learned from the COVID-19 pandemic are included such as continuing to host hybrid meetings. New strategies include incorporating technology such as Mural, virtual engagement events such as online open houses, plan specific outreach strategies, micro plans, expanded partnerships, and the equity planning tool. The PIP has an equity focus to ensure the NFRMPO is engaging with all members of the community. The PIP outlines a social media policy that outlines the expectations for interactions on social media. The public comment period for the PIP closed on November 5<sup>th</sup>.

James asked how the public comment period went. Cunningham noted there have been a few comments from staff from local agencies.

#### NFRMPO Transportation Demand Management (TDM) Plan

Gordon provided an overview of Transportation Demand Management (TDM) and the contents of the <u>TDM Action Plan</u>. The goals are to improve data collection, invest in infrastructure and resources, enhance partnerships and collaboration, communicate the purpose, benefits, and successes of TDM, and to create and enhance regional TDM programming. Some of the recommendations are already underway, including the creation of a US34 Transportation Management Organization (TMO), the RideNoCo Trip Discovery Tool, the creation of a Safe Routes to School subcommittee under NoCo Bike & Ped, outreach, and resource development. The public comment period ended on October 28<sup>th</sup>. Multiple comments were received including reorganization of information within the plan and requests for additional data.

Rennemeyer asked what the next steps are for the US34 TMO. Gordon noted the next steps are to apply for grant funding to hire somebody to begin building the TMO. Olson asked what measurements will be used to ensure the strategies outlined in the plan are successful. Gordon stated potential measurements are the number of strategies implemented and the amount of money that is invested in TDM strategies.

#### FAMLI Opt Out

Mallette noted Colorado voters approved Proposition 118 in November 2020 that created the FAMLI program. Governments can opt out of the program if they provide equal or better benefits than what the FAMLI program provides. The NFRMPO provides a greater benefit to employees than provided by the FAMLI program. Mallette requested the NFRMPO opt out of the program and noted staff could choose to opt in if they choose to do so.

Rennemeyer asked if there are any staff members who wanted to opt in. Mallette noted she has not heard from any staff members. Olson asked if an employee were to choose to opt into the program, would they continue to receive NFRMPO benefits. Mallette noted they would receive both benefits.

#### **COUNCIL REPORTS:**

<u>Transportation Commission</u> – Bracke thanked everyone who helped with the Transportation Commission's North I-25 tour. Bracke noted she participated in the opening of the new Bustang Outrider service from Sterling to Denver and Greeley.

<u>CDOT R4 Update</u> – Paddock noted I-25 construction is continuing. CDOT finished the process of acquiring the US-85 right-of-way. CDOT Region 4 submitted a Railroad Crossing Elimination Grant for two railroads on US-34. There is an anticipated Request for Proposals (RFP) for the design of the SH14 and I-25 interchange. There will be a study on US287 from Ted's Place to the Wyoming border looking at passing lanes and safety improvements.

STAC Report – A written report was included.

<u>Colorado Transportation Investment Office</u>- A written report was included.

<u>I-25 Coalition</u> – James stated Paddock covered all the updates provided at the I-25 Coalition.

<u>US34 Coalition</u> – James noted officials were asked to return to their respective governing bodies to confirm that they are willing to provide funds that will go towards the local match for the TMO grant.

<u>Nonattainment Area Air Pollution Mitigation Enterprise (NAAPME)</u> – Stephens stated NAAPME has collected \$328,000 so far from the retail delivery fee. Rideshare dollars have not come in yet as those are collected quarterly. This fee is enough to repay the loan given by CDOT for startup costs. Herman Stockinger and Jessica Ferko were named to the board. There will be a meeting in December to approve the Annual Report.

<u>Front Range Passenger Rail District</u> – Olson noted the board has extended an offered Andy Karsian for the General Manager/ Executive Director position of the Front Range Passenger Rail District.

<u>Host Council Member Report</u> – Mallo introduced Mark Jackson and Bill Becker. Jackson noted Nicole Hahn is the new City Engineer for the City of Loveland. Work is continuing on westbound US34. Loveland is finishing the design and right-of-way acquisition for the Taft Avenue-Eisenhower Boulevard intersection project. Becker outlined redevelopment projects in Downtown Loveland.

#### APPROVAL OF THE OCTOBER 19, 2022 TAC MINUTES

Oberschmidt moved to approve the October 19, 2022 TAC minutes. Donaldson seconded the motion, which was approved unanimously.

#### AIR QUALITY AGENDA

**Regional Air Quality Updates** – Chuang stated the Air Pollution Control Division (APCD) discovered an error for oil and gas emissions in the draft 2008 SIP, raising the emissions estimates. APCD has withdrawn some chapters of the 2008 SIP to ensure the Plan will reach the ozone standard by 2026. Bornhoft stated the Planning Council requested to review the GHG IGA between the NFRMPO, CDOT, and CDPHE prior to Executive Director Mallette signing. NFRMPO staff are working on identifying and prioritizing Disproportionately Impacted (DI) communities for the GHG mitigations process and will complete one GHG Transportation Report in 2023 for the *2050 RTP* and *TIP*.

#### ACTION ITEMS

**2022** Public Involvement Plan (PIP) – Relford moved to recommend Planning Council adopt the *2022 PIP*. Oberschmidt seconded the motion, which was passed unanimously.

**November 2022 TIP Amendment** – Cunningham stated CDOT requested revisions to the *North I-25: Design Build* project in the *FY2023-2026 TIP*, specifically changes to current and previous funding for the project. Oberschmidt moved to recommend Planning Council approve the November 2022 TIP Amendment. White seconded the motion, which was passed unanimously.

**Transportation Demand Management (TDM) Action Plan** – Gordon reviewed changes to the *TDM Action Plan* based on public comment and Planning Council discussion. Hornkohl moved to recommend Planning Council adopt the *TDM Action Plan*. Relford seconded the motion, which was passed unanimously.

#### **PRESENTATION**

**Electric Vehicle (EV) Planning Roundtable** –Zahra Al-Saloom, Colorado Energy Office (CEO), Diego Lopez, Northern Colorado Clean Cities (NCCC), and Becca Stock from Xcel Partners in Energy presented available technical assistance and funding opportunities for EV planning. Al-Saloom described the Charge Ahead Colorado program, which incentivizes investments in DI and Income Qualified (IQ) communities. Lopez explained he can assist local communities with Supplemental Environmental Program Funding and Fleet and Community Audits. Stock explained the Partners in Energy program, which supports communities evaluating goals, needs, and opportunities for EV infrastructure.

**US34 Transportation Management Organization (TMO) Proposal** – Gordon reviewed progress on the US34 TMO proposal, including the scope, service area, and potential budget. The US34 Coalition and the NFRMPO will apply for a TMO Seed Grant through CDOT and local communities are reviewing the draft application.

#### **DISCUSSION ITEMS**

**FY2023-2025 Additional Allocations** – Cunningham reviewed two options for allocating \$13.5M additional funding from all NFRMPO funding sources through FY2025 after the most recent reconciliation from CDOT Region 4. The two options are to leverage all grant funds to fully fund waitlisted projects regardless of funding program or to follow the existing policy of fully funding projects in that funding's waitlist. Either way, a Call for Projects will be held to award the remaining funds. TAC members expressed support for the first option. Cunningham will follow up with project sponsors.

**FY2022-2023 Unified Planning Work Program (UPWP) FY2023 Task Updates** – Karasko stated Planning Council approved the FY2023 Budget Amendment #1, which includes additional funding for Tasks 2.3, 3.3, and 5.3. These Tasks are being updated based on the budget amendment.

# Executive Summary of the North Front Range Metropolitan Planning Organization Community Advisory Committee

November 10, 2022

#### **CDOT Bike and Pedestrian Planning**

Annelies van Vonno, CDOT Bicycle and Pedestrian Program Manager, explained how bicycle and pedestrian planning fits into the CDOT planning process. Policy Directive 1602.0 and the Procedural Directive 1602.1 guide CDOT's bicycle and pedestrian work, with the Policy Directive being updated in 2023. York asked about the exemption criteria in the update to the Policy Directive. Van Vonno explained bicycle and pedestrian improvements can be dropped if they amount to more than 20 percent of project cost. York stated he believes that should change with the update. CDOT will be updating their Bicycle and Pedestrian Plan soon. Van Vonno explained the Revitalizing Main Streets, Multimodal Transportation and Mitigation Options Fund (MMOF), Transportation Alternative (TA) Program, and Safe Routes to School programs. CDOT is updating their Roadway Design Guidelines and Colorado Downtown Streets guidance. CDOT is expanding its Bicycle and Pedestrian Counting Program, including working with Streetlight to get big data, designating US Bicycle Routes, and implementing Safe Routes to Parks programming.

#### **Complete Streets**

Gordon explained what complete streets are, some local examples, and what the NFRMPO's role is in complete streets planning. York stated the new Lemay Avenue overpass at Vine Street is a good example of complete streets in the region, improving safety and adding bicycle and pedestrian infrastructure.

#### **NFRMPO Active Transportation Planning**

Rouser explained bicycle and pedestrian planning in the region, including micromobility on trails, Safe Routes to School, regional bicycle counter program, walk and bicycle audits, and the Shift Your Ride Challenge. Van Vonno stated CDOT is working on updating its bicycle counting program and is looking to reach out to MPOs and local communities to get better and calibrated data. York asked if connectivity was considered in the walk audits. Rouser agreed it is important to integrate trails and other multimodal connections together.

# BACKGROUND

Colorado voters approved Proposition 118 in November 2020, creating a state-run Paid Family and Medical Leave Insurance (FAMLI) program.

The FAMLI program provides all Colorado workers access to paid leave to take care of themselves or their families during life circumstances that pull them away from their jobs. FAMLI will be available starting on January 1, 2024, and contributions to the program are paid by the employee and the employer beginning January 1, 2023.

The NFRMPO currently provides a greater benefit to employees at no cost to the employee. Opting out is not permanent and will be revisited biannually. At this time, it is in the best interest of our employees to opt out.

NFRMPO provides employees with sick time off, disability benefits (short and long-term), and parental leave, all at no cost to the employee.

Employees have the option to individually opt into FAMLI directly with the state FAMLI Agency if they feel it would be of benefit to them. To participate, an employee must notify the agency and pay the employee portion of the premium directly to the agency (.45% of the employee's wages in 2023). NFRMPO staff received an email from the Executive Director on October 26,2022 outlining this program and the reasons for opting out. Staff had no questions. This was a discussion item at the November 3, 2022, Council meeting.

# Background

The NFRMPO updates the Public Involvement Plan (PIP) prior to the adoption of the long-range Regional Transportation Plan every four years, with the last update adopted by Planning Council in March 2019. In accordance with federal legislation, metropolitan planning organizations (MPOs) are required to engage in a metropolitan planning process that creates opportunities for public involvement, participation, and consultation throughout the development of the Regional Transportation Plan (RTP) and the Transportation Improvement Program (TIP).

The <u>2022 PIP</u> was developed in consultation with the TAC and the NFRMPO Community Advisory Committee (CAC) and incorporates:

- Lessons learned from public involvement during the COVID-19 pandemic;
- Guidance from the Infrastructure Investment and Jobs Act (IIJA);
- Updated and new engagement strategies;
- Evaluation strategies and metrics; and
- A social media policy

The <u>2022 PIP</u> was released for the 45-day public comment period on September 21 and closed on November 5. Public comment from four individuals or agencies were received during this time as well as discussion at the October 19 TAC meeting and November 3 Planning Council meeting. **WHEREAS**, the November 2022 TIP Amendment increases the amount of emissions benefits and either improves or does not substantially reduce the cost effectiveness of those emissions benefits; and

**WHEREAS**, the FY2023-2026 TIP remains fiscally constrained.

**NOW, THEREFORE, BE IT RESOLVED,** the North Front Range Transportation & Air Quality Planning Council hereby amends the FY2023-2026 TIP by revising the following funding and projects:

- TIFIA, FASTER Safety, FASTER Bridge Enterprise, NHPP/SHF, State HPTE Loan, and Local funding:
  - Revising *North I-25: Design Build* to reflect actual amounts of previously budgeted and currently programed funds by decreasing current funding by a total of \$50M and decreasing previous funding by a total of \$13,079K.

# Re: Transportation Demand Management (TDM) Action Plan

# Background

For 2022, two of Executive Director Mallette's goals set by the Planning Council related to developing and expanding transportation demand management (TDM) in the region: developing a regional TDM program and creating a Transportation Management Organization (TMO). To achieve these goals, NFRMPO staff recommended drafting a TDM Action Plan and convening a TDM Work Group.

Throughout 2022, the TDM Work Group guided NFRMPO staff's development of the TDM Action Plan. The TDM Action Plan lays out a vision for TDM in the region:

# People in Northern Colorado will have the resources, support, and mobility options to make informed choices about how they travel around the region

To implement this vision, there are five goals with associated recommendations and strategies:

- 1) Enhance **partnerships** and collaboration between local communities, businesses, regional and State agencies, and other interested parties
- 2) Create and enhance **regional TDM programming** to optimize people throughput
- 3) Improve **data** collection to support new and expanded investments and programming
- 4) **Invest** in infrastructure and resources to provide additional options and help people make informed transportation choices
- 5) **Communicate** the purpose, benefits, and successes of providing mobility options

Bolded words are key themes that arose in discussions with the TDM Work Group.

Some recommendations from the TDM Action Plan are already underway:

- NoCo Bike & Ped is discussing a regional Safe Routes to School program
- The US34 Coalition is discussing incorporating a TMO for the corridor
- Determining next steps for the LinkNoCo project to increase transit in the region



The TDM Action Plan was released for public comment between September 28, 2022 and October 28, 2022. Seven comments were submitted, resulting in the following updates to the following updates to the final TDM Action Plan:

- Reordered goals to prioritize programming and partnerships
- Inclusion of VMT and Bustang ridership tables in the Existing Conditions section
- Additional detail and clarification within recommended strategies, including ensuring outreach to different populations.

**WHEREAS,** the NFRT&AQPC requested development of a regional Transportation Demand Management (TDM) program and establishment of a Transportation Management Organization; and

**WHEREAS,** TDM is a relevant strategy to achieving GHG reductions set forth in the GHG Transportation Report adopted by the NFRT&AQPC on October 6, 2022; and

**WHEREAS**, the TDM Action Plan was released for a 30-day public comment period and feedback was incorporated into the final plan; and

**WHEREAS**, the TDM Action Plan goals are to improve data collection, invest in infrastructure and resources, enhance partnerships and collaboration, communicate the purpose, benefits, and successes of TDM, and to create and enhance regional TDM programming

**NOW, THEREFORE, BE IT RESOLVED THAT the North Front Range Transportation & Air Quality Planning Council** adopts the TDM Action Plan.

Following the approval of the FY2022 Budget Amendment #1 at the November Planning Council Meeting, NFRMPO staff has updated the FY2023 Tasks to reflect the additional funding available, including:

- \$90,000 in additional salary to be allocated across all relevant Tasks to reflect salary increases for all NFRMPO staff.

# Re: FY2023-2025 Additional Funding Allocations

# Background

The NFRMPO has held two Calls for Projects in the last year with the funding to be awarded based on the funding estimates available at the time. Based on the October 2022 Reconciliation provided by CDOT Region 4, the NFRMPO has approximately \$13.5M in federal and state funding available across five funding programs between Fiscal Years (FYs) 2023 and 2025. The two most recent Calls for Projects have waitlisted and unfunded amounts of \$11.6M.

Due to the influx of funding from the Infrastructure Investment and Jobs Act (IIJA), the NFRMPO has a significant amount of FY2023 funds available (federal fiscal year 2023 runs from July 1, 2022 to June 30, 2023). Additionally, the funds listed for FY2023 also include FY2022 funds which have been rolled into FY2023. To allow for the utilization of the federal funds in a timely manner, the NFRMPO outlined a proposal for awarding waitlisted and unfunded projects current fiscal year funding regardless of the funding program originally awarded the project.

The proposal was presented to TAC at their meeting on November 16, 2022. Following the TAC discussion, NFRMPO staff revised the proposal which has been sent to project sponsors and TAC members for review. To allow time for TAC's feedback to be incorporated the additional allocation tables and further information will be provided in the Planning Council Meeting Handouts Packet.
