CALL TO ORDER

Vice-Chair White called the meeting to order at 1:00 p.m.

PUBLIC COMMENT

There was no public comment.

APPROVAL OF THE FEBRUARY 15, 2023 TAC MINUTES

Hornkohl moved to approve the February 15, 2023 TAC minutes. Barzak seconded the motion, which was approved unanimously.

AIR QUALITY AGENDA

Regional Air Quality Updates – Moore noted the RAQC is halfway through the emission inventory improvement process for oil and gas and is continuing to hold control strategy committee meetings.

Bornhoft stated the Greenhouse Gas (GHG) Transportation report for the <u>2050 RTP</u> is in development, with Planning Council adoption expected in July.

CONSENT AGENDA

No items this month.

ACTION ITEMS

March 2023 TIP Amendment- Cunningham described the March 2023 TIP Amendment, which includes four revision requests from CDOT and the City of Fort Collins.

Hornkohl recommended Planning Council approve the March 2023 TIP Amendment. Herrera seconded the motion, which was approved unanimously.

2050 RTP Goals, Objectives, Performance Measures, and Targets (GOPMT)- Rouser outlined the NFRMPO's proposed GOPMT for the <u>2050 RTP</u> and updates to Regional Targets based on Planning Council feedback at their March meeting. Rouser noted the changes to non-motorized facilities, fixed-route transit service per capita, and non-single occupant vehicle (SOV) commute trips targets. Hahn asked if there is a measure regarding safety. Rouser noted safety is covered under the Federal safety performance measure.

Hahn recommended Planning Council approve the <u>2050 RTP</u> GOPMT. Relford seconded the motion, which was approved unanimously.

PRESENTATION

No items this month.

DISCUSSION ITEMS

Willow Bend Trail Scope Change – Bryan Harding, Loveland, explained the background of the *Willow Bend* project, including the five grants being used to complete the project. The City's request is to isolate the funding received through previous NFRMPO Calls for Projects to a one-mile section of the project to simplify the funding process. Harding stressed the project will still be completed in full. Karnik asked if there are any criteria on what qualifies as a major and a minor scope change. Cunningham noted the TIP defines a major scope change as any sponsor-directed alteration that requires a modification in a project's activity, location, or schedule which triggers a review of the National Environmental Policy Act (NEPA) process or air quality analysis. A minor scope change does not meet the criteria of a major scope change and does not change the project type. TAC agreed this qualifies as a minor scope change and does not require Planning Council approval.

10th **Street Access Control Implementation Project Funding Exchange** – Karnik outlined the history of the *10*th *Street Access Control Implementation* Project and noted the project was completed, but the awarded funding could not be used due to the contractor not being able to provide the required Buy America documentation. The City of Greeley is requesting the STBG funds be reallocated to the *83*rd *Avenue Roadway Improvement Project.* Relford asked for the project location to see if it encroaches on Weld County jurisdiction. Karnik clarified the location and that it does not encroach on Weld County jurisdiction. Cunningham clarified the process if TAC agrees that this constitutes a major scope change Planning Council would have to approve the exchange. If Council does not approve the exchange, the funding will be returned to the STBG pool to be awarded in a future Call for Projects. Herrera asked if this

funding exchange would change the projects local match. Cunningham noted the local match would be affected, but the project already had local overmatch. TAC agreed this qualifies as a major scope change and will require Planning Council approval.

2023 Call for Projects Overview – Cunningham noted the next Call for Projects will likely open August 4th, with the applications due October 6th. This call will award FY2026 and FY2027 funding. Cunningham outlined the five funding programs included in this call and the projected dollar amounts for each. There are an estimated \$25M available across all five funding programs for this Call. Hahn asked if there has been a decision regarding what entities are eligible to apply for these funds. Cunningham noted there has not been a discussion. Hahn suggested there should be a continous conversation on this topic. Relford asked if staff is recommending the same set asides from the last Call for Projects. Cunningham stated only the \$50,000 for RAQC air quality modeling is the only proposed set aside at this time. TAC recommended retaining program-specific maximum project award limits instead of creating additional limits. TAC provided feedback on Staff's recommended changes to the scoring committee and equity considerations.

FY2024-2025 Unified Planning Work Program (UPWP) Tasks- Karasko discussed the two new tasks for the FY2024-FY2025 UPWP, which are Complete Streets and Safe Routes to School. Karasko noted the LinkNoCo and Safety tasks have been expanded. Karasko requested TAC review the FY2024-FY2025 UPWP and provide comments April 14th.

NFRMPO 10 Year List of Projects Discussion- Karasko noted the NFRMPO is in the process of updating the 10-Year List of Projects that will be included in CDOT's 10-Year List. Karasko provided an overview of how Planning Council developed the 10-Year Project list in 2019. TAC requested to have a workshop the week of March 27th to further discuss this prior to the April Planning Council meeting.

OUTSIDE PARTNERS REPORTS

NoCo Bike & Ped Collaborative – Written report was provided.

Regional Transit Agencies – No comments.

Mobility Updates – Schmitt noted Hanna Johnson left the NFRMPO to work for the City of Greeley. The Mobility Program is hiring two positions: Mobility Planner and Mobility Specialist. Both of those job descriptions are on the NFRMPO website. Via Mobility is launching a pilot program between Loveland and Estes Park that will run until June 30th.

REPORTS

March Planning Council Meeting Summary Draft – A written report was provided.

Mobility Committee Updates – A written report was provided.

NFRMPO Information and Data Requests- Karasko stated there has been a request to provide a list of regularly occurring data requests, so NFRMPO staff compiled a list that outlines each regularly occurring data request, how frequently this request happens, and which quarter will it generally be requested. Karasko requested TAC members let Staff know if there are any other requests that they would like to be included in this list.

ROUNDTABLE

Bornhoft set a deadline for Land Use review for the Land Use Model for Friday, March 17th. If TAC members have questions, TAC members should reach out to Bornhoft prior to the 17th.

Herrera noted the Town of Windsor received two bids for the *SH257 and Eastman Park Drive Intersection* project. Herrera stated asphalt, concrete, and paving prices are 10-13 percent higher than anticipated, and traffic signal materials were around 30 percent higher. Windsor is reallocating funding from another project to assist with the additional costs.

Rouser reminded TAC members to complete the construction update data request and requested TAC members reach out if they have any projects they would like to include in the NFRMPO's newsletter.

Gordon noted the NFRMPO is wanting to do outreach for the <u>2050 RTP</u> with elected officials, including City and Town Council members who are not on the NFRMPO Planning Council. Gordon requested TAC members reach out with recommendations.

Cunningham stated the NFRMPO will be reaching out for operations and maintenance costs for the financial plan for the <u>2050 RTP</u>.

White noted Johnstown is moving forward with traffic signal at Carslon Boulevard and SH60 with bids being 30 percent higher than anticipated. Johnstown is moving into design for improvements on Colorado Blvd and SH60. White is retiring on April 14th.

Karnik noted the City of Greeley received a SS4A grant for a Target Zero Action Plan, and the City Council has approved a new Transportation Master Plan (TMP).

Oberschmidt stated the City of Evans will be starting construction on the 37th Street project in mid-March and to help spread the word that the intersection of 47th Avenue and 37th Street will be closed for 60 working days.

Barzak noted the Town of Severance received four bids for the CO392/WCR23 Traffic Signal Project and is evaluating the bids and working with CDOT to award. Construction is on pace to begin in April.

MEETING WRAP-UP

Final Public Comment – There was no final public comment.

Next Month's Agenda Topic Suggestions – No suggestions.

Committee Discussion

This is the first and only time TAC is scheduled to see the April 2023 Off-Cycle TIP Amendment.

Supporting Information

The 30-day Public Comment period for the April 2023 Off-Cycle TIP Amendment began on April 7, 2023 and concludes on May 7, 2023.

An environmental justice analysis is included for the project.

Funding Types and Uses

Surface Treatment Pool (SUR) is a funding program pool utilizing both Federal (NHPP) and State (SHF) funds The Surface Treatment Pool consists of projects and related work elements required to resurface highways in accordance with the CDOT Pavement Management Program.

Advantages

• TAC recommending approval by the NFRMPO Planning Council will ensure available funds are assigned to projects in a timely manner and the FY2023-2026 TIP remains fiscally constrained.

Disadvantages

• None noted.

Analysis/Recommendation

• Staff supports adding the April 2023 Off-Cycle TIP Amendment to the FY2023-2026 TIP.



Re: NFRMPO 10-Year Priority List 2050 RTP Update

Background

In early 2020, CDOT developed a 10-Year Strategic Pipeline of Projects to create a list of the State's top transportation priorities and provide a living list of projects to incorporate into CDOT's Statewide Transportation Improvement Program (STIP) as the four active fiscal years change as well as the <u>2045 Statewide Plan</u>.

In response to this, the NFRMPO created its own 10 Year list of projects. The NFRMPO's 10-Year List has been updated twice since 2020, once each in 2021 and 2022. To ensure the NFRMPO's 10-Year list continues to reflect the region's priorities and remains a living document in the NFRMPO's upcoming 2050 Regional Transportation Plan (RTP) currently under development, NFRMPO Staff has begun the process of reviewing the Tier 1 list to ensure any changes to the projects' status are accurately reflected and that the projects on the list are still the region's top priorities. Working with the 2050 RTP timeline, the deadline for completing this update is June 2023.

Staff reviewed the lists of projects and requested updated project information from project sponsors by Tuesday, January 31, 2023. The updated list of projects was discussed at the March 6, 2023 Planning Council meeting. Following discussion of the priority corridors and projects, Planning Council members requested TAC discuss the corridors and projects to determine if the projects on the list should be based on corridor priority or based on individual project priority. TAC discussed the project lists at their March 15, 2023 meeting and requested a workshop to discuss the lists and projects in detail. A workshop was scheduled for March 27, 2023. Additional information was requested from TAC members by March 31, 2023. The project list outcome from the workshop was discussed at the April Planning Council Meeting.

Following the discussion at the Planning Council meeting and to avoid confusion between the NFRMPO's list of priority projects and the CDOT 10-Year Plan as well as to reflect the purpose of the list more accurately, staff has renamed the list the NFRMPO 10-Year Priority List.

Based on Planning Council's discussion at the April 6, 2023 meeting, NFRMPO staff is moving forward with the corridor-based list the project has reflected since its creation in 2019. Additionally, the Intersection line recommended during the TAC Workshop on March 27, 2023 has been removed from the Roadway list based on Planning Council's feedback.



Action

NFRMPO staff would like the TAC's feedback on the updated list of projects. This is a discussion item and TAC's feedback will inform the final list of priorities going to Planning Council for discussion at their May 4, 2023 meeting.

Re: 2023 Congestion Management Process (CMP)

Background

According to the Federal Highway Administration (FHWA), the CMP is a systematic and regionally accepted approach for managing congestion. Every four years, the NFRMPO reviews its Congestion Management Process (CMP) to manage congestion in the region and identify the appropriate strategies to address it. CMPs build on the performance-based planning approach of the Regional Transportation Plan (RTP), identify and evaluate mitigation strategies, and describe potential implementation of described strategies.

In the process of developing the CMP, staff undertook the following steps:

- Identified congested segments of Regionally Significant Corridors (RSCs) using data from local communities, INRIX, the National Performance Management Research Dataset (NPMRDS), and other sources;
- Evaluated strategies and their implementation since the 2019 CMP; and
- Analyzed implementation strategies for addressing congestion.

The attached presentation identifies the congested corridors, tiered strategies, and implementation schedule of the <u>2023 CMP</u>. Staff have also developed an <u>Arc Story Map</u> to make it easier to understand the CMP.

Action

Staff requests TAC review the definition of congestion, Performance Measures, CMP Strategies Inventory, and implementation recommendations. Staff are looking for TAC feedback or clarification on missing information.





Congestion Measure: Travel Time Index









Congestion Measure: Number of Crashes









Congestion Measure: Percent of devices connected by fiber on RSCs







Re: 2023 Call for Projects

Background

The NFRMPO will be holding a Call for Projects to award approximately \$22M Federal and State funds for fiscal years 2026 and 2027. The 2023 Call for Projects will be a consolidated call for all four NFRMPO controlled federal funding sources: Congestion Mitigation and Air Quality (CMAQ), Surface Transportation Block Grant (STBG), Carbon Reduction Program (CRP), and Transportation Alternatives (TA).

Following the CDOT STAC meeting on April 6, NFRMPO Staff decided to withhold the Multimodal Transportation and Mitigation Options Fund (MMOF) from the 2023 Call for Projects. The distribution formula for the MMOF program, which was developed in 2021, will be revisited by the Transportation Commission in Summer 2023 which may affect the anticipated funding available for the NFRMPO to award to local agencies. Additional legislation going through the State legislature may affect the MMOF program. Due to these uncertainties, the NFRMPO determined it would be best to award future MMOF funds at a later time.

At the NFRMPO Planning Council meeting on April 6, Staff presented an Equity Resources tool which details the Federal and State guidance on equity considerations, including Justice40, Disproportionately Impacted (DI) communities, and Environmental Justice (EJ). Included in this was a recommendation to create an index of equity areas within the NFRMPO to use as a guide for equity considerations in the 2023 Call for Projects. The Equity Resources tool, including the Equity Index map, can be found at the following link: https://storymaps.arcgis.com/stories/62223542d7f84c529c288e7ab7836d5a.

The NFRMPO is currently working on developing the 2023 Congestion Mitigation Process (CMP). In an effort to better integrate NFRMPO plans and programs into the Call for Projects process, Staff will discuss with TAC ways in which CMP processes and strategies can be accounted for in the process.

Action

Staff requests TAC members review the <u>Equity Resources tool</u>, specifically the <u>Equity Index section</u>, to discuss equity consideration inclusions in the process. A presentation will be sent out in the handouts packet with further discussion items and information.

METROPOLITAN PLANNING ORGANIZATION (MPO) AGENDA

EXECUTIVE DIRECTOR REPORT:

Mallette provided an update on legislation that the NFRMPO is tracking starting with HB23-1101 going to a second conference committee. HB23-1276, will allow for the Bridge and Tunnel Enterprise to expand their scope. SB23-268 would require CDOT to provide more information and transparency with the Ten-Year Transportation Plan. Mallette reported on the VanGo program that provided a status update. Mallette stated the NFRMPO received a shoutout for the 2045 RTP System Performance Report in the Model Long-Range Transportation Plans: A Guide for Performance Based Planning document created by FHWA and there are virtual meetings on outreach for the 2050 RTP on April 12th and 20th.

ACTION ITEMS:

<u>2050 RTP Goals, Objectives, Performance Measures, and Targets (GOPMT)</u> – Rouser outlined the NFRMPO's proposed GOPMT for the 2050 RTP and updates to Regional Targets.

Olson **moved** to approve the <u>2050 RTP</u> GOALS, OBJECTIVES, PERFORMANCE MEASURES, AND TARGETS. The motion was **seconded** by Heid and **passed** unanimously.

<u>March 2023 TIP Amendment</u> – Cunningham reviewed the projects included in the March 2023 TIP Amendment from CDOT and the City of Fort Collins.

Stephens **moved** to approve *RESOLUTION NO. 2023-07 THE MARCH 2023 AMENDMENT TO THE FY2023-2026 TRANSPORTATION IMPROVEMENT PROGRAM (TIP)*. The motion was **seconded** by Olson and **passed** unanimously.

DISCUSSION ITEMS:

10th Street Access Control Implementation Project Funding Exchange – Paul Trombino, Public Works Director, Greeley, requested that Council consider reallocating funding from the 10th Street Access Control Implementation Project to 83rd Avenue Roadway Improvement Project due to contractor error. Council supported the reallocation.

<u>2023 Call for Projects Preview</u> – Cunningham noted the next Call for Projects will open August 4th with applications due October 6th. Cunningham outlined the four funding programs included in this call and the projected dollar amounts. NFRMPO Staff recommended not awarding FY2026 and FY2027 Multimodal Transportation Options Fund (MMOF) funds during this Call for Projects due to uncertainty surrounding MMOF funding estimates.

<u>Equity Resources</u> – Cunningham showcased the equity resources story map which provides an overview of the Federal, State, and regional equity resources. Cunningham provided an overview of the different equity requirements, including Justice40, Disproportionately Impacted Communities, and Environmental Justice..

<u>NFRMPO 10-Year List of Projects</u> – Karasko provided an overview of TAC's suggestions from the March 27th TAC workshop. These suggestions include keeping projects separate instead of going corridor by corridor, prioritize I-25 projects, and adding a line item for intersection improvements. Olson and James expressed their opposition to keeping projects separate and requested to continue to prioritize corridors.

<u>FY2024-2025 Unified Planning Work Program (UPWP)</u> – Karasko discussed the two new tasks for the FY2024-FY2025 UPWP, which are Complete Streets and Safe Routes to School. Karasko noted the LinkNoCo and Safety tasks have been expanded. Karasko requested TAC review the FY2024-FY2025 UPWP and provide comments April 14th.

Bitzer shared updates regarding the resumption of Via Mobility Services in rural Weld County. Vehicles and drivers are ready to go pending execution of a contract between CDOT and Weld County for the service. A service boundary map can be found here and will be available to older adults (60+) and individuals with disabilities across the service area with the service also being available to the general public in rural areas outside of the NFRMPO boundaries.

Teets asked about coverage within the cities of Greeley, Evans, and LaSalle to which Schmitt and Bitzer answered that those areas are excluded but that 60+ Ride is making progress on acquiring wheelchair accessible vehicles to provide service throughout Weld County, including in the urban areas.

DISCUSSION ITEMS

3) Mobility Case Studies

All

Schmitt shared a RideNoCo Call Center Case Study:

Case Study 1: An adult in Greeley-Evans dislocated her hip and needs temporary, affordable, accessible transportation around the area, including from one hotel to another. Lived outside of GET paratransit boundaries and Squad One was reserved for mental health crises and not physical health needs leaving zTrip as the only option for the person.

Bedingfield mentioned that 60+ Ride is currently working with the cities of Greeley, Evans and Garden City to be able to help with addressing needs such as this. Powell mentioned that GET can conduct eligibility assessments for temporary disabilities provided that they are assessed as if the disability is permanent. There is a possibility that someone can be served within the service boundaries of paratransit service even if their home address is outside of the boundaries.

Cundall asked Bedingfield when 60+ Ride's new program to serve adults with disabilities in Weld County could launch and Bedingfield replied that they're eyeing a 2024 pilot for the expanded population served.

Teets asked if Heart&SOUL Paratransit would be able to serve in this situation to which Schmitt and Johnson explained that their boundaries are pretty constrained to picking up passengers in Fort Collins, Loveland and Laporte.

4) Mobility Action Plan Updates

Schmitt lead a discussion of changes to the 2023 Mobility Action Plan (MAP) as outlined in the slides in the packet. Teets suggested including underrepresented geographic areas and communities under both Goal 3 and Goal 7 of the MAP.

5) Integrating United Way Goals

Members had a discussion on the most effective way to incorporate the transportation goals from the Age-Friendly Weld Action Plan and Weld's Way Home into the working activities of the WCMC. Members came to an agreement that some kind of subcommittee structure would be the best way of advancing these goals and reporting back on progress at WCMC meetings with future NFRMPO Mobility Staff working with committee members to shepherd this subcommittee. With this framework in place, members agreed to wait until new Mobility staff are hired and the Age-Friendly Action Plan is officially adopted in order to form this subcommittee, likely later in 2023.

Members discussed the successes and failures of the Outreach & Education Working Group and agreed that even if not a formal working group per se, having a standing agenda item to discuss outreach and collaboration opportunities was beneficial for partners. Johnson suggested keeping the current format and adding a progress table with annual goals for WCMC members to discuss and check-in on at WCMC meetings.

GREELEY EVANS TRANSIT NEWS AND UPDATES

Powell introduced Hanna Johnson as the City of Greeley's new Mobility Coordinator and expanded upon GET's evolution to become a more comprehensive mobility umbrella. GET is currently putting together RFPs for a Mobility Plan and customer-facing apps. Poudre Express held a stakeholder meeting recently reviewing schedule patterns and ridership. Since adjustments to the Poudre Express schedule in August, the average ridership per hour has increased from 3-4 riders per hour to 5-7 riders per hour. Ridership is approaching return to pre-pandemic levels.
