MPO MEETING PROCEDURAL INFORMATION

1. The order of the agenda will be maintained unless changed by the MPO Planning Council Chair (MPO Chair).

2. "Public Comment" is a time for citizens to address the Planning Council on matters that are not specifically on the agenda. Each citizen shall be limited to a total of two (2) minutes time for public comment, or at the discretion of the MPO Chair.

3. Before addressing the Planning Council, each individual must be recognized by the MPO Chair, come and stand before the Council and state their name and address for the record. (All proceedings are taped.)

4. For each Action item on the agenda, the order of business is as follows:

- > MPO Chair introduces the item; asks if formal presentation will be made by staff
- Staff presentation (optional)
- > MPO Chair requests citizen comment on the item (two minute limit for each citizen
- Planning Council questions of staff on the item
- Planning Council motion on the item
- Planning Council discussion
- Final Planning Council comments
- Planning Council vote on the item

5. Public input on agenda items should be kept as brief as possible, and each citizen shall be limited to two (2) minutes time on each agenda item, subject to time constraints and the discretion of the MPO Chair.

6. During any discussion or presentation, no person may disturb the assembly by interrupting or by any action such as applause or comments. Any side conversations should be moved outside the meeting room. Courtesy shall be given to all speakers.

7. All remarks during the meeting should be germane to the immediate subject.

Vice-Chair Mallo called the MPO Council meeting to order at 6:00 p.m.

Public Comment:

No comments were submitted.

Move to Approve Agenda and Minutes

Heid **moved** to *APPROVE THE OCTOBER 5, 2023, MEETING AGENDA.* The motion was **seconded** by Baszler and **passed** unanimously.

Stephens **moved** to *APPROVE THE SEPTEMBER 7, 2023, MEETING MINUTES.* The motion was **seconded** by Baszler and **passed** unanimously.

Lead Planning Agency for Air Quality Agenda

Vice-Chair Mallo opened the Air Quality portion of the meeting.

REPORTS:

Air Pollution Control Division (APCD)

Ferko reported APCD is hosting a Greenhouse Gas Intensity Protocol public meeting on October 16, and Greenhouse Gas Inventory meetings on October 17 and 24. APCD will begin a toxic air contaminants monitoring program by January 1, 2024, and is seeking input and feedback to inform the location of monitoring sites at a meeting on November 14. AQCC granted the request for an ozone-related hearing in December for revisions addressing Ozone Nonattainment requirements. Those interested will need to sign up for party status by October 12.

<u>Regional Air Quality Council (RAQC)</u> A written report was provided.

NFRMPO Air Quality Program Updates

Mallette introduced Dena Wojtach, who is the new NFRMPO Air Quality consultant. Wojtach stated AQCC is establishing a GHG Trading Program and control requirements for 18 industrial facilities and set a SIP revision rulemaking hearing for December 2023. RAQC shared updated modeling data, showing all monitors will meet the 75-ppb requirement by 2026. APCD has proposed updates to the SIP, including the State Emissions Inventory. Wojtach explained proposed revision, including a new Regulation 29 for Lawn and Garden Equipment. RAQC proposed an early alternative that would include commercial entities. Wojtach explained potential revisions to Regulation 3, establishing fees for GHG emissions statewide that apply to 2024 emissions.

Council was asked to consider if they wanted to file for party status for the December rulemaking hearing. Mallette clarified Motor Vehicle Emissions Budgets (MVEB) are the key aspects of the hearing process in December of importance to the NFRMPO. People can propose changes to MVEBs, so applying for party status can be beneficial. Stephens stated there have not been enough discussions at Planning Council to commit to applying for party status. Questions from Councilmembers should be funneled through Mallette, who will work with Wojtach. Wojtach clarified the Council could apply for party status and then cancel it later or could potentially apply late and explain further internal discussions were needed.

Wojtach reviewed upcoming meetings that may relate to Council, including AQCC and RAQC meetings. Mallette highlighted the Air Quality and Health Symposium, which is an opportunity to meet Air Quality Control Commission Commissioners.

ACTION ITEMS:

<u>NFRMPO Letter to EPA</u> – Mallette reviewed the letter to EPA, focused on requesting a meeting with EPA about background ozone and non-locally controllable emissions in the Mountain West. Mallette noted a few edits to the letter have been made since the September meeting but none are substantial. Stephens and Canonico highlighted concerns about signing onto the letter, focusing on health and equity impacts. Mallette clarified the letter is focused on the difficulty of achieving the standards. The letter will include communities that want to sign, including the name of the person and their title.

Olson **moved** to *SEND THE LETTER REQUESTING A MEETING WITH THE EPA, INCLUDING THE COMMUNITIES WHO SUPPORT THE LETTER.* The motion was **seconded** by Heid and **passed** unanimously.

Metropolitan Planning Organization (MPO) Agenda

Vice-Chair Mallo opened the MPO portion of the meeting.

REPORTS:

<u>Report of the Chair</u> No reports this month.

Executive Director Report

Mallette stated VanGo[™] started a new route from Loveland to Gunbarrel, and Fort Collins is investigating funds to incentivize new VanGo[™] routes in the City. Stephens asked if the incentives will be for city employees or people who work within the city. Schmitt clarified this is being reviewed with the city, but leaning toward those who work in Fort Collins. Olson asked if ridership was rebounding, and Mallette stated ridership has been flat. Gordon will be presenting at the TDM Conference in October 2023 about TDM efforts in Northern Colorado.

<u>TAC</u>

A written report was provided.

<u>Mobility</u>

A written report was provided.

ACTION ITEMS:

<u>September 2023 TIP Amendment</u> – Cunningham stated there were four revision requests for the September 2023 TIP Amendment. Cunningham noted the *FY2024-2027 TIP* that was previously adopted is still waiting for final approval, but amendments will be incorporated once it is approved. The 30-day public comment began on September 13, 2023 and concludes on October 12, 2023. TAC discussed the revisions and recommended Planning Council approval. Stephens stated there will be further discussion about the TMO Incubator funds based on conversations at the US34 Coalition meeting.

Olson **moved** to approve RESOLUTION NO. 2023-18 *APPROVING THE SEPTEMBER 2023 AMENDMENT TO THE FY2023-2026 TRANSPORTATION IMPROVEMENT PROGRAM (TIP).* The motion was **seconded** by Heid and **passed** unanimously.

DISCUSSION ITEMS:

<u>CDOT Boundary Discussion</u> – Herman Stockinger, CDOT Deputy Director, stated CDOT has been reviewing the planning process based on HB1101 and are drafting recommendations. The recommendations will be taken to the November Transportation Commission meeting. Stockinger stated there are no recommendations for changes to the NFRMPO and Upper Front Range Transportation Planning Region (UFR TPR) boundaries in this process. A recommendation will be to ensure no community can have double representation on STAC. Stockinger stated there will be recommendations for term limits for the Transportation Commission Chair and to rotate the Chair position between urban and rural TPRs. Mallo asked when STAC representatives are determined. Mallette responded STAC representatives are determined when elections happen, and there will be updates to the NFRMPO's Articles of Association after TC takes action to add that UFR TPR and the NFRMPO will work together to make sure one jurisdiction is not the STAC representative of both TPRs. Stephens highlighted some administrative changes that will help with transparency and make the process more accessible.

<u>FY2023 TIP Delay Review</u> – Cunningham stated the NFRMPO does an annual review of projects that have been awarded funding by the NFRMPO to ensure funding is used in a timely manner. The review focuses on milestones when the project goes to ad or issues a Notice to Proceed. Cunningham stated there were 25 projects that were reviewed. Three projects are requesting a second delay, 14 projects are being delayed for the first time, and seven projects have met their milestones and are not considered delayed. Olson clarified the projects have 10 years to expend their funds, and Cunningham added the delay review is to make sure funds are being expended in a reasonable time. Baszler asked how long projects can request delays. Cunningham stated deeper conversations are needed beyond a second delay.

COUNCIL REPORTS:

<u>Transportation Commission</u> – Paddock stated five commissioners were onboarded, and they will be reviewing funding recommendations and HB1101.

<u>CDOT R4 Update</u> – Paddock stated asphalt paving is done, and concrete paving is almost done on I-25. Starting the week of October 9, northbound I-25 from SH14 to Owl Canyon Road will have grinding and slab replacement work bringing the roadway down to one lane. Landscaping work is continuing at Prospect Road. CDOT is working on the first Segment 5 construction package to begin in Spring 2024. Olson stated there was a recommendation at STAC that members talk to their Transportation Commissioners to discuss support for HB1101. Paddock stated there were more than 13,000 lane violations on I-25 in the Express Lane in Denver within the last week, and fees will rise to \$75.

<u>STAC Report</u> – A written report was provided.

Colorado Transportation Investment Office (CTIO) – A written report was provided.

<u>I-25 Committee</u>- Mallette stated CDOT will go for the first construction package for Segment 5, which is expected to take three paving seasons to complete. CDOT will continue setting up tolling equipment on segments 6, 7 & 8 through the fall, test the equipment in the winter, and start tolling in the spring.

<u>US34 Coalition</u> – Stephens stated the US34 Coalition hopes to have a contractor early next year, and voted to make the US34 Coalition members the new members of the board at least initially. The Coalition also identified participants for the Scoring Committee to evaluate responses to the RFP: Loveland, Estes Park, Greeley, Weld County, and CDOT. The US34 Coalition will continue discussion on how to expend the \$100,000 in Carbon Reduction Program (CRP) funds. The US34 Coalition will hold election of new officers at their next meeting.

<u>Nonattainment Area Air Pollution Mitigation Enterprise (NAAPME)</u> – Stephens stated NAAPME met on September 28, with presentations about bus rapid transit in the Denver region. Stephens noted the Enterprise would like to balance geographic equity, DI communities, air quality benefits, and shovel-ready projects. Gordon will be presenting to the NAAPME in October or November. Mallette stated she and Gordon met with Pakbaz and asked about local match, transit operations, and other process questions for NAAPME funds.

<u>Front Range Passenger Rail District</u> – Olson stated he will forward the minutes from the FRPR District to include in the Council packet. There was a meeting on September 11, where elected officials got to test out a hydrogen-powered train. Olson stated the District is discussing staffing and contractors to complete the necessary work. The District will hold an in-person meeting on October 27 to set vision, goals, and strategies. The District is working on legislation being reviewed by Transportation Legislative Review Committee (TLRC), including removing Senate approval for Commissioners.

<u>Host Council Member Report</u> – Cochran stated new businesses are opening in LaSalle. The Town is working through their bridge grant for the Main Street bridge, with plans to start the project in Spring. Cochran reported the Town paved its last dirt street in town. The Town is working on its budget.

EXECUTIVE SUMMARY of the TECHNICAL ADVISORY COMMITTEE (TAC) North Front Range Transportation and Air Quality Planning Council October 18, 2023

APPROVAL OF THE SEPTEMBER 20, 2023 TAC MINUTES

Oberschmidt moved to approve the September 20, 2023 TAC Minutes. Buckman seconded the motion, which was approved unanimously.

AIR QUALITY AGENDA

Regional Air Quality Updates – Moore reviewed the ozone season, stating 2023 was a moderate season with 27 action alert days, 10 of which exceeded the 75ppb standard, and 17 which exceeded the 70 ppb standard.

Karasko stated FHWA provided a conformity determination for the <u>2050 RTP</u> on October 11. The Conformity Determination for the <u>FY2024-2027 TIP</u> is expected to be provided in the following weeks.

ACTION ITEMS

FY2023 TIP Delay Review – Cunningham reviewed the FY2023 TIP Delay Review. Relford approved the FY2023 TIP Delay review, granting a first extension to the 14 projects requesting a first extension, and recommending Planning Council approve a second extension for the projects experiencing a second delay. Oberschmidt seconded the motion, which was approved unanimously.

October 2023 Off-Cycle TIP Amendment – Cunningham reviewed the October Off-Cycle Amendment to the <u>FY2023-2026 TIP</u> requested by CDOT which included adding one new project to the TIP. Public comment opened on October 3, 2023, and will close on November 2, 2023. Relford recommended Planning Council approve the September 2023 TIP Amendment to the <u>FY2023-2026 TIP</u>. Buckman seconded the motion, which was approved unanimously.

DISCUSION ITEMS

William Neal/Ziegler Intersection Improvements Scope Change – Cunningham reviewed the process for TIP project scope changes, requesting the TAC determine if the scope change was minor or major. Buckman stated the *William Neal/Ziegler Intersection Improvements* project was awarded FY2024-2025 Transportation Alternatives (TA) funds in early 2023. The project scope included local overmatch to build a connection to the Poudre River Trail. Fort Collins is requesting the removal of the trail connection and associated local overmatch to be completed as part of a separate developer project. TAC discussed and determined the scope change was minor and may be completed by NFRMPO staff through an Administrative Modification to the TIP.

Transportation Projects Lessons Learned – Oberschmidt reviewed several lessons learned in completing transportation projects at the municipal level including planning, funding, engineering, construction, scheduling, and coordination. TAC members provided input on lessons learned from various local agencies and requested lessons learned discussions be part of future TAC agendas. TAC members requested similar discussions at future meetings.

2023 Fare Free Summer – Karasko presented an overview of the outcomes of the 2023 fare free summer initiative for the three regional transit providers, noting all three agencies experienced an increase in ridership over the summer. CASTA provided a statewide update which showed the trend was seen across the state. Donaldson asked if the funding program will be continued in future years. Karasko stated the funding will continue to be available annually.

SHIFT Driving Discussion

Cunningham outlined the history, purpose, and content of the SHIFT Driving Course hosted by Bicycle Colorado. Pauline asked if there are any types of incentives for individuals to complete the course, similar to discounts on car insurance given by AAA upon completion of a driving course. Nathalie noted concerns about the Colorado Safety Stop and asked if there was research following the implementation of the rule in Colorado. Cunningham stated she would reach out to Bicycle Colorado for answers to the proposed questions. The group noted continued interest in the course and asked if a discussion on it could be on the future agenda. Cunningham agreed the discussion could continue either in November or December.

NFRMPO Outreach Strategy Evaluation

Cunningham presented the questions emailed to the group for consideration regarding the Outreach Strategy for the 2050 RTP. The group noted a target audience which was missing was engagement with youth and college age students. The group suggested connecting with the transportation departments at the universities, boys' and girls' clubs, girl scout and boy scouts, and YMCA. The group noted there should be a greater effort placed on engaging with chambers of commerce in the region. York asked if non-profits providing transportation are included in NFRMPO outreach efforts. Cunnigham noted many of the group are involved in the mobility programs with RideNoCo and that the NFRMPO periodically presents to the mobility committees in both counties.

Cunningham asked for feedback on the ArcGIS StoryMaps and social media content. The group noted the StoryMaps could be more concise, hitting the high-level points and directing interested users to where more information could be found. Regarding the social media content, Courtney noted community members may be more likely to share when presented photos of congestion and other types of issues. York noted it would be helpful for people to know where photos had been taken within the region which may help solicit feedback. The group discussed ways in which the NFRMPO may be able to solicit photo submissions from the public.

NFRMPO Call for Projects – Submitted Projects Overview

Cunningham reviewed the NFRMPO's Call for Projects timeline, the funding available, and the total funding request for projects which submitted applications during the Call. Cunningham reviewed the funding types and presented the projects which were submitted for consideration. More information on projects recommended for funding will be presented at a future meeting.

The meeting was adjourned at 7:38 p.m.

Re: CDOT Boundary recommendations – HB 23-1101

BACKGROUND

The NFRMPO has been involved with the legislatively mandated HB23 -1101 Transportation Planning Region (TPR) Boundary Study, which requires CDOT to complete a study on or before November 30, 2023, and the study shall report on:

- The Consistency and Transparency of the Transportation Planning Process Across the Transportation Planning Regions (TPRs);
- The boundaries of the (TPRs);
- Membership of the State Transportation Advisory Committee (STAC); and
- Membership of the Special Interim Transit and Rail Advisory Committee (TRAC).

CDOT provided opportunities for public comment and considered input from stakeholders throughout the State. The legislation protects rural Colorado's transportation interests by mandating that the number of rural TPRs cannot be reduced from the current number. Further, CDOT was mandated to look at specific factors in determining boundary changes. Metropolitan Planning Organization (MPO) boundaries were not considered in this effort, as these must abide by federal regulations.

Based on presentations to STAC and the NFRMPO Planning Council on October 5, 2023, the NFRMPO Planning Council is in support of the recommendations being forwarded to the Transportation Commission for their consideration. The NFRMPO is supportive of structural and procedural recommendations. The changes affecting the NFRMPO are:

- State a preference in TC rule that relevant TPR governing documents do not allow a single political jurisdiction to represent two TPRs on STAC. The NFRMPO will amend its Article of Association so that the NFRMPO and Upper Front Range Transportation Planning Region (UFR) do not have representation from the same political jurisdiction.
- No boundary modifications are recommended.

The NFRMPO does not offer an opinion on the discussed boundary modifications for South Central and Southeast TPR or Intermountain TPR.

RESOLUTION NO. 2023-20 OF THE NORTH FRONT RANGE TRANSPORTATION & AIR QUALITY PLANNING COUNCIL APPROVING THE OCTOBER 2023 OFF-CYCLE AMENDMENT TO THE FY2023-2026 TRANSPORTATION IMPROVEMENT PROGRAM (TIP)

WHEREAS, 23 CFR §450.326 requires the development of a fiscally constrained Transportation Improvement Program (TIP) for Metropolitan Planning Organizations through the continuing, cooperative, and comprehensive ("3C") multimodal transportation planning process; and

WHEREAS, the North Front Range Transportation & Air Quality Planning Council as the Metropolitan Planning Organization (MPO) is the agency responsible for developing the TIP in accordance with the above stated regulation; and

WHEREAS, transportation projects programmed in the current TIP for FY2023-2026 are consistent with the 2050 Regional Transportation Plan (RTP), adopted September 7, 2023; and

WHEREAS, the Air Quality Conformity Findings conducted on the FY2023-2026 were positive and this TIP Amendment does not change the positive conformity findings on the FY2023-2026 TIP; and

WHEREAS, the October 2023 Off-Cycle TIP Amendment increases the amount of emissions benefits and either improves or does not substantially reduce the cost effectiveness of those emissions benefits; and

WHEREAS, the FY2023-2026 TIP remains fiscally constrained.

TAC may also recommend Planning Council remove the funds from the project and fund another project or return the funds to the pool for the next fiscal year if the funding can be guaranteed by CDOT. WHEREAS, the FY2023-2026 TIP identifies a procedure for delayed projects to promote the effective and timely use of federal funds by ensuring projects receiving Congestion Mitigation and Air Quality (CMAQ), Surface Transportation Block Grant (STBG), Carbon Reduction Program (CRP), Transportation Alternative (TA), and/or Multimodal Transportation and Mitigation Options Fund (MMOF) funds (or their equivalents in past or future federal surface transportation legislation) are making progress; and

WHEREAS, the FY2023 TIP Project Delay Review found three project have a second delay:

- Greeley's *59th Ave and O Street Roundabout* project \$1,329K STBG;
- Loveland's North Taft Ave & US34 Intersection Widening/Improvements project \$3,331K CMAQ; and
- Fort Collins' US287 Intersection Improvements project \$877K STBG

WHEREAS, the delay for the project is outside of the control of the project sponsor.

NOW, THEREFORE, BE IT RESOLVED, the North Front Range Transportation & Air Quality Planning Council hereby approves the extensions for the three projects with anticipated ad dates through the remainder of the current State Fiscal Year, which concludes on June 30, 2024.

Statewide Transportation Advisory Committee (STAC) Meeting Summary

Date/Time: Thursday, October 5, 2023; 8:30 a.m. - 12:00 p.m. STAC Meeting October 5, 2023 Recording

Highlights and Action Items

Legislative Report - Emily Haddaway and Jamie Grim CDOT Office of Policy and Government Relations (OPGR)

- Update on State Legislature
 - The Transportation Legislation Review Committee (TLRC) reviewed drafts of 10 bills and 5 got picked to be carried on next year, including: 1. Vulnerable road user protection enterprise, 2. Child Passenger Safety Education, 3. Railroad safety requirements regarding train length and increased firefighter training, 4. Accountability requirements added in towing carrier regulations, and 5. Methods to Increase the use of transit with transit tax credits, universal passes, etc.
- Update on Federal Legislation
 - Congress was able to pass a last minute spending bill that will last through until Nov 17th to put together an Appropriation bill to keep the government funded right before Thanksgiving.
 - For the Federal Aviation Administration (FAA), the nomination hearing for Michael Whitaker occurred yesterday in the House and he was asked a lot of questions on housing shortages.
 - UAW (United Auto Workers Union) strike continues and will have ripple effects across transportation
 - NHTSA (Natl Highway Traffic Safety Admin) in first half of year- there have been 19,505 motor vehicle crash fatalities

HB1101 TPR Boundary Review Study Update - Herman Stockinger, CDOT Deputy Director

- Several TPRs that are under consideration for boundary changes requested they be left as is.
- SETPR in particular voiced opposition to the concept of Southeast and South Central TPRs merging. It was explained that the merging may require legislative action if all recommendations create less than 10 rural TPRs. Also the TC has the final say on the decisions regarding TPR Boundary Changes.
- Many staff recommendations pertained to administrative practices of TPRs and the STAC. One example is STAC term limits for Chair and Vice Chair, and a list of guiding documents TPRs need to develop and maintain.
- A recommendation to split the Intermountain TPR into two planning regions is under consideration, but the exact boundaries recommended are not yet determined.
- In addition, CDOT staff suggested having eastern El Paso County merge into the Pikes Peak Region. El Paso County staff have thus far expressed opposition to this concept. More discussions with PPACG and El Paso County, along with Central Front Range TPR are scheduled to occur.
- TPR members with concerns regarding the TPR Study recommendations were advised to reach out to their TC representatives to express their concerns.

Program Distribution: MMOF Program - Marissa Gaughan, Multimodal Planning Branch Manager and Michael Snow, CDOT MMOF Program Manager

- STAC confirmed the September recommendation to maintain the existing 81%/19% Urban/Rural split and the existing Rural distribution formula weightings.
- STAC Actions:
 - STAC unanimously moved to recommend the amended Urban MMOF formula as presented in the meeting material (with changes from the existing formula highlighted).
 - A motion was also approved recommending CDOT return 50% of the remaining unspent funds previously set aside for MMOF Program administration to the pool for Local MMOF projects instead, then consider 2% annual set-aside of future MMOF funds.

Budget Workshop FY 24 Budget Amendment - Jeff Sudmeier, CDOT Chief Financial Officer

- Discussed the \$179 million Federal Redistribution dollars CDOT received, the largest amount received to date.
- A presentation on the amended FY 2024 Budget was provided. Key requests for approval included Fixing Poor Interstate pavement for \$13 million, and Avalanche Mitigation funds for \$8 million.
- A discussion on amendments pertaining to State Culverts, Rest Areas ,Guardrails, Rockfall Mitigation, Mountain Rail, Capital Construction, Light Fleet, Hot Spots, and the Joint Operating Area (JOA) Program amendments also occurred.

Central Federal Lands - Elijah Henley and Andrew Valdez

- Central Federal Lands coordination with CDOT and the TPRs occurred with the 2045 Statewide Transportation Plan and the 2045 Regional Transportation Plan development. Appendix C of the RTPs generally covered projects in CFL.
- CFL will make more of an effort to coordinate in the 2050 Statewide Plan development.
- The concept is for CFL to work with CDOT and local jurisdictions on transportation projects in an effort to leverage resources. Also, the intent is to sync the 2050 Statewide Transportation Plan with the federal long-range transportation plan update's schedule.

STAC Work Plan - Darius Pakbaz, CDOT Division of Transportation Development Director

- The STAC was provided the opportunity to bring up any topics they would like to cover in 2024.
- STAC agreed to not hold a meeting in December this year.
- Staff suggested the work plan include a general planning refresher in early 2024 for the benefit of new and existing STAC members after the November elections.
- CDOT staff is planning to have a 10-Year Plan lessons learned overview and discussion in March 2024, then in April discuss what the next 10-Year Plan will include before finalization in May 2024.
- The Freight Plan update can be brought to the STAC for discussion in January 2024.
- STAC discussed the concept of moving the location of meetings throughout the state. This will be discussed further, in addition to the number or frequency of in-person meetings to hold.
- The next STAC Chair/Vice Chair election is scheduled for October 2024.
