
Read on for the latest mobility updates in Northern Colorado.

RideNoCo Dashboard - Q2 Review

From July 2024 to October 2024 the RideNoCo call center received:

126 calls

70.6% of the calls received were from people aged 60+56.3% of the calls needed help getting to Medical Appointments10.3% of the calls were from Veterans.



Key Themes for the 3rd Quarter of 2024:

What we heard:

- A need for more wheelchair-accessible transportation
- Affordable last-minute medical trips
- Trips to medical appointments in the **Denver area**
- Providers are not able to accept ride requests because of lack of drivers
- Post-procedure with anesthesia transportation
- **Service gaps** between Fort Collins and Loveland, Greeley and Loveland, North Front Range and Anschutz Medical Center, Windsor and Fort Collins, and Severance.


NFRMPO staff continue to work with the Larimer County and Weld County Mobility Committees to discuss these and other needs to learn more about the barriers as well as potential solutions from the providers' perspective. The barriers include service areas that are limited to single cities or single counties and a lack of specialized wheelchair-accessible vehicles for unique situations as mentioned above.

NFRMPO staff are also investigating which providers in the region can schedule rides and arrange drivers for clients who speak Spanish and other languages to ensure all members of our community have access to transportation options that meet their needs. Through their partnership with the Mobility Team, three transportation providers have been given access to **LanguageLink** live interpretation services to enhance their ability to serve non-English speakers in the community.

RideNoCo Coordination Project Launches

Culminating years of planning and development of the NFRMPO's expanded Mobility Program is the RideNoCo Coordination Project that launched in July 2024, completing the third and final phase of the RideNoCo implementation.

Utilizing the Transactional Data Specification (TDS), the RideNoCo Call Center is now directly connected with the scheduling systems of three regional volunteer transportation providers: 60+ Ride, Rural Alternative for Transportation (RAFT), and SAINT Volunteer Transportation. The TDS technology allows RideNoCo Mobility Specialists to



conduct initial intake over the phone and seamlessly send prospective client information over to the referred agency, thus cutting down on the time and number of phone calls necessary to get new clients registered with and utilizing transportation providers in the region.

Additionally, the TDS technology allows participating providers to share client information and trips with one another as well as coordinate trips across multiple agencies, opening up new destinations and service efficiencies for riders and agencies alike.

I-25 North Mobility Hubs Opening at Berthoud and Centerra Loveland

As part of the I-25 North Express Lanes Project, a series of Mobility Hubs along the corridor either have opened or are in the process of opening over the coming months to serve the **Bustang North Line**, **Bustang to Broncos**, **RamsRoute** as well as connecting local transit services.

In August, the Berthoud Mobility Hub opened at I-25 and State Highway 56 with Bustang offering free fares to and from this new station through October 15. October will also see the opening of the Centerra Loveland Mobility Hub for both Bustang services and COLT as well as the Firestone-Longmont Mobility Hub at State Highway 119. There is a new transportation service in town and it's called Carepool!

Carepool uses a rideshare model to provide fully accessible transportation for Older Adults and People with Disabilities. Unlike Uber or Lyft, Carepool provides door-through-door service and drivers are trained to assist people with healthcare needs. Drivers are CPR-certified and can provide first aid assistance when needed. Drivers use their own vehicles but, if someone needs a wheelchair-accessible vehicle, Carepool will provide a van for the trip. They have partnered with **UCHealth** in Northern Colorado, allowing hospital administrators to book rides for patients and utilize Carepools software for insurance billing. More good news, **they can even transport people who are getting discharged from the hospital!** Below is a link to an article from the Denver Gazette and Carpool's website for more information.

NFRMPO Wraps Up Summer Outreach







Between April and September, **NFRMPO** and **RideNoCo** staff attended 15 events and cohosted five Bike to Work Day Stations around the region. During the events, Staff interacted with 5,859 community members across 12 communities. Throughout these events, community members of all ages played Transportation Trivia, learning about transit, air quality, bike and ped trails, mobility options, and transportation safety. Trivia questions spark conversations allowing NFRMPO staff to learn about transportation needs and concerns in the region, and community members to learn something new about transportation in Northern Colorado.

RideNoCo partnered with **The UCHealth Aspen Club** and hosted 2 Transportation Signup Fairs in September, one in Loveland and one in Fort Collins. There attendees could visit with transportation providers to get more information and sign-up for services. It was a great turn out and we were able to help many people with their transportation needs in Larimer and Weld County. A huge thanks to SAINT, Transfort & Dial-A-Ride, zTrip, and Rural Alternative for Transportation (RAFT) for participating and helping so many people get where they need to go!

Vanpooling: A Practice in Collaboration



It's been said that "Alone we can do so little; together we can do so much" (Helen Keller).

This idea was brought home recently in working to form VanGo™"s newest route from Denver to Colorado State University.

Originating from a larger lunchtime webinar hosted by CSU, a group of four, scattered amongst the Denver Metro area, joined the Operations and Fleet Manager of VanGoTM in a 'quick' Teams meeting to discuss the possibility of a new route. All working or studying at CSU, the dynamic amongst the group clicked from the

start, and in less than an hour we had a new route formed. One person mapped where everyone was coming from, while another vetted potential meeting points. In a world that can seem to grow more divisive by the minute, these strangers came together, worked together, and VanGo™ was able to facilitate getting them all on a route that makes each person's commute an easier and more affordable one.
