
Read on for the latest mobility updates in Northern Colorado.

RideNoCo Dashboard - Year in Review

From January 1, 2024, to December 31, 2024, the RideNoCo call center received:

368 calls & 4,957 website visits

62.8% of the calls received were from people aged 60+61.4% of the calls needed help getting to Medical Appointments47.3% of the calls were from Veterans.



Key Themes for 2024

What we heard:

- There are no volunteer providers with wheelchair-accessible vehicles that serve the City of Greeley
- Lack of affordable transportation options for riders who are just outside of provider boundaries
- Shortage of drivers makes it difficult to schedule rides
- No low-cost transportation options for medical appointments that require anesthesia
- No low-cost wheelchair transportation in Loveland that is outside the COLT Dial-A-Ride service area
- No transportation options in Wellington except for the Senior Resource Center which only travels within a 15-mile radius of Wellington
- Hard to find affordable last-minute trips
- Need to expand service areas

Service gaps: Between Loveland and Fort Collins, Larimer to Weld County, Larimer County side of Windsor to the Weld County side of Windsor, Larimer County to the Denver area, weekend and evening service, and service to mountain communities.

NFRMPO staff continue to work with the Larimer County and Weld County Mobility Committees to discuss these and other needs to learn more about the barriers as well as potential solutions from the providers' perspective. The barriers include service areas that are limited to single cities or single counties and a lack of specialized wheelchair-accessible vehicles for unique situations as mentioned above.

NFRMPO staff are also investigating which providers in the region can schedule rides and arrange drivers for clients who speak Spanish and other languages to ensure all members of our community have access to transportation options that meet their needs. Through their partnership with the Mobility Team, three transportation providers have been given access to **LanguageLink** live interpretation services to enhance their ability to serve non-English speakers in the community.

As 2024 comes to a close, I am thrilled to reflect on a transformative year for mobility in Northern Colorado. This year, the NFRMPO celebrated the launch of two groundbreaking initiatives that will shape the future of our region.

The **RideNoCo** program took a giant leap forward with the implementation of the **Transactional Data Specifications (TDS) project.** This cutting-edge technology enables interoperability between our systems and local mobility providers, streamlining services for residents and expanding accessibility. We're proud that this innovation earned the distinction of **Transit Project of the Year** from the Colorado Association of Transit Agencies (CASTA).

We also established the region's **first Transportation Management Organization (TMO), GoNoCo34.** TMOs are partnerships that coordinate transportation options for employers, residents, and commuters within a defined area, reducing traffic congestion and promoting sustainable travel. This is just the beginning of our journey in this space, as we aim to become leaders and incubators for future TMOs while championing Transportation Demand Management strategies regionally.

We also want to take a moment to express our gratitude to **Cory Schmidt** who recently left his role as Mobility Director. His vision and dedication have been instrumental to our progress. The search is underway to find a new leader who will continue building on this strong foundation.

Looking ahead to 2025, we anticipate another impactful year as we expand GoNoCo34, deepen regional collaboration, and embark on updating our Coordinated Human Services Transit Plan. Together, we are making strides toward a more connected and equitable transportation system for all.

The Centerra Loveland Mobility Hub Ribbon Cutting

Located at 3020 Kendall Parkway in Loveland, the Centerra Loveland Mobility Hub is now open and celebrated with a ribbon-cutting ceremony on October 22, 2024. This hub serves the Bustang North Line, Rams Route, Bustang to Broncos, and the City of Loveland Transit (COLT). The Bustang platform is located in the median of I-25. The location allows buses to pull off into the station, pick up and drop off passengers, and get back on the road without leaving the interstate.

Vanpooling: VanGo™ is Driving into 2025



As the year ends, it's a wonderful time to reflect on the strides made in 2024. A subsidy by the City of Ft. Collins helped us gain new riders and routes—including a new Denver to CSU route aided in part but a rigorous campaign by CSU-while our biggest promoter, our participants, played an even larger part—taking advantage of VanGoTM's Rider Recruitment Incentive. There is no better compliment to our program than when a current participant recommends us.

With retirements and relocations, VanGo™ numbers stayed static. This isn't viewed as a negative—in fact the opposite. Steady and consistent is a solid foundation to work from. We are here to make a change after all. And 30+ years later we're still doing it. Removing single occupancy vehicles off our local roads and making people's everyday commutes easier and more affordable.

So, what's in store for 2025? While not looking to be predictive, there are some great road signs ahead, Potential for new routes to a location we've long sought—more on that in the next article if it does come to fruition, fleet issues—getting new vans—appears to be easing, a new TMO in place--GoNoCo34--headed up by a staunch vanpool supporter, a mid-year vanpool push by another TMO--Commuting Solutions—and the continued availability of the Ft. Collins based subsidy, all land as positives both for the VanGo™ program and for our regional air quality goals. But of course, we won't discount our greatest asset and greatest source of new participants, current VanGo™ participants. We look forward to paying out more rider recruitment incentives in 2025.
