Questions and Answers

The following questions and answers are provided as a matter of information to clarify issues raised about the RFP. To the extent that changes to the RFP are required based on the questions received, the RFP has been modified as noted above in the RFP section of this Addendum.

Item	Questions and Answers		
2.1	Question: Is it correct to assume that the outreach strategy is more stakeholder-focused (with stakeholders representing specific constituent groups) than broader community-focused, given that NFRMPO has conducted recent public outreach campaigns? Or is it anticipated that the broader community will need to be solicited for input on corridor prioritization and selection? Answer: The outreach strategy should include methods for receiving input from the general public as well as from stakeholders. Consistent check-ins with a stakeholder committee or group will be beneficial as well as periodic public meetings or feedback loops with the general public.		
2.2	Question: Can you describe the NFRMPO's role versus the consultant's role in assembling and facilitating the stakeholders? Answer: NFRMPO staff can work with the consultant to assemble and facilitate stakeholders. NFRMPO staff has identified some key stakeholders, though this is not an exhaustive list.		
2.3	Question: Can you confirm that DBE participation is not a part of the project's selection criteria? Answer: DBE is not a part of the project's selection criteria as shown in Table 3.
